PROVIDING FOR THE REVISED GUIDELINES IN THE OPERATION OF THE MUNICIPAL TRACTOR AND IMPOSING EIGHT HUNDRED PESOS (PHP800.000) PER HOUR CHARGE FOR ITS RENTAL.

WHEREAS, the Local Government Unit of General Trias has acquired a farm tractor under the counter-funding scheme with the Department of Agriculture (DA) - RFU No. IV - A and the Office of Former Congressman Antonio A. Ferrer of the 6th District of Cavite by virtue of the Memorandum of Agreement (MOA) designed in 2011 for the benefits of the farmers in the municipality through Sanggunian Resolution No. 08 - 28;

WHEREAS, as provided in the memorandum of agreement for the program mentioned above, a rental fee of Php700.00 is being charged to the users of the tractor which is insufficient to cover up the operation and maintenance cost of the municipal tractor;

WHEREAS, an additional charge of Php100.00 to the rental fee being collected was proposed by the Municipal Agriculturist;

WHEREAS, aside from the Municipal Agriculture Office, other concerned offices in the municipality like the General Services Office and the Municipal Treasury shall get involved in the implementation of the program;

WHEREAS, clear procedures in the rental of the municipal tractor shall be established;

WHEREFORE, on motion of SB Member Florencio D. Ayos and SB Member Walter C. Martinez duly seconded by SB Member Richard R. Parin, SB Member Gary A. Grepo, SB Member Mario C. Amante, SB Member Christopher N. Custodio, SB Member Kerby J. Salazar, SB Member Jonas Glyn P. Labuguen and SB Member Jowie S. Carampot, be it

RESOLVED, AS IT IS HEREBY RESOLVED to provide for the Revised Guidelines in the operation of the municipal tractor and imposing Eight Hundred Pesos (Php800.000) per hour charge in its rental, and to enact an ordinance to be read as follows:



PESOS (PHP800.000) PER HOUR CHARGE IN ITS RENTAL.

Be it enacted by the Sangguniang Bayan, that:


Section 1. RULES AND REGULATIONS. - In the rental of the municipal tractor, the following guidelines shall be enforced:

- The equipment shall be open to all farmers in General Trias and adjacent town,
- Borrower shall be required to fill-up request form at the Municipal Agriculture Office to be acted upon on a first-come first-served basis,
- Upon approval of the filled up request form by the Municipal Agriculturist or her designated representative, this shall be forwarded to the Officer-in-Charge of the equipment for proper scheduling and entrust to the General Services Office (GSO) Staff for operation,
- The Farm Tractor Operator and the mechanic shall conduct routine inspection of the equipment to ensure its serviceability before cultivating the farm lot of the requisitionee,
- The renter shall be charged with the rental fee off Php 800.00/hour for using the farm tractor. This will be for the operation and maintenance of the tractor, gas, oil and automatic transmission fluid (ATF),
- Before cultivating the farm lot, the Officer-in-Charge shall issue approved scheduled list of requisitionee's farm lots to be validated by the operators (GSO) indicating the location of the farm lot, estimated area in hectare and estimated time of operation. (The tractor operators shall see to it that before operation the area must be clear of any obstacles that may damage the tractor), and
- Upon completion of the operation, the mechanic/operators shall see to it that the farm tractor is in good condition for the succeeding operation.

Section 2. REPEALING CLAUSE - All previous guidelines inconsistent with this ordinance shall be deemed repealed or modified accordingly.

Section 3. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.






