WHEREAS, Lenny Villa was the son of Romulo M. Villa,
one of our most beloved and distinguished townmates and
prominent citizen of General Trias;

WHEREAS, the brutal death of young Villa from the
callous hands of his homicidal "brothers" in the initia-
tion rites has brought anguish to Lenny's family;

WHEREAS, we utterly condemn the senseless death of
Lenny and demand from the proper government authorities
their swift and decisive action for the criminal prose-
cution of those individuals responsible for his death;

justice and that no whitewash will happen to it;


WHEREAS, we appeal to the honorable members of the



RESOLUTION NO. 12-91

On motion of SB Member Cornelio A. Grepo duly seconded by SB Member Ruben M. Parani, this body

RESOLVED, as it is hereby resolved to enact an ordinance requiring a permit to construct before a new construction, renovation, addition or repair is made on existing structure and prescribing fees therefor, to read as follows:

MUNICIPAL ORDINANCE NO. 1-91

AN ORDINANCE REQUIRING A PERMIT TO CONSTRUCT BEFORE A NEW CONSTRUCTION, RENOVATION, ADDITION OR REPAIR IS MADE ON EXISTING STRUCTURE AND PRESCRIBING FEES THEREFOR.

Be it enacted by the Sangguniang Bayan in session duly assembled.

Section 1. - Any person, natural or juridical, shall secure from the office of the Mayor a "Permit to Construct" before proceeding with any construction, repair, addition or rehabilitation of an existing structure.

Section 2. - The Office of the Municipal Planning and Development Coordinator shall assess the cost of construction, repair, addition or rehabilitation to determine the cost of fees therefor.

Section 3. - The following fees are hereby prescribed:

For industrial edifice or structure:

Cost less than ₱500,000, a minimum fee of	₱ 20.00
₱500,000 to ₱2,000,000	500.00
Above ₱2,000,000	1,000.00

For commercial building or structure:

Cost less than ₱200,000	₱ 20.00
₱200,000 to ₱1,000,000	500.00
Above ₱2,000,000	1,000.00

Residential (single, apartment, condominium)

Cost less than ₱100,000	₱ 20.00
₱100,000 to ₱500,000	100.00
More than ₱500,000 to ₱1,000,000	250.00
Above ₱1,000,000	500.00

Section 4. - Violation of this ordinance shall subject the owner of the edifice or structure to a penalty of one percent (1%) of the fee supposed to be paid.

Section 5. - This ordinance shall take effect upon approval.

RESOLVED, as it is hereby resolved, to enact an ordinance prescribing locational clearance fee for housing and land use, to read as follows:

MUNICIPAL ORDINANCE NO. 2-91

AN ORDINANCE PRESCRIBING LOCATIONAL CLEARANCE FEE FOR HOUSING AND LAND USE.

Be it enacted by the Sangguniang Bayan in session duly assembled.

Section 1. - Any person, natural or juridical, desiring to use the land for any purpose shall secure a locational clearance from the Office of the Mayor to ascertain whether or not such purpose is in accordance with the land use plan of the municipality.

Section 2. - A fee of one-fourth of one percent of the assessed value of the land is hereby prescribed for any locational clearance issued.

Section 3. - This ordinance shall take effect upon approval and shall form part of the Local Government Tax Code of the Municipality.
