RESOLUTION NO. 75-94

RESOLVED, to enact an ordinance adopting a Comprehensive Town Plan and Zoning Regulations for the municipality of General Trias, Cavite and providing for the administration, enforcement and amendment thereof and for the repeal of all ordinance in conflict therewith, and to be designated as Municipal Ordinance No. 1-94.

MUNICIPAL ORDINANCE NO. 1-94

AN ORDINANCE ADOPTING A COMPREHENSIVE TOWN PLAN AND ZONING REGULATIONS FOR THE MUNICIPALITY OF GENERAL TRIAS, CAVITE AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH.

Be it enacted by the Sangguniang Bayan duly assembled in regular session.

WHEREAS, the Municipality of General Trias complies with the requirement of Memorandum Circular No. 54, prescribing the guidelines governing Section 20 of RA 7160 otherwise known as the Local Government Code of 1991, authorizing fourth class municipalities like General Trias to reclassify five (5%) of its agricultural areas to non-agricultural uses;

WHEREAS, the Sangguniang Bayan had participated in various sectoral plan deliberation, review and public hearing conducted by the Municipal Development Council of General Trias, Cavite;

WHEREAS, RA 7160 otherwise known as the Local Government of 1991, provides that local government unit shall in conformity with existing laws continue to prepare its respective comprehensive land use plan enacted through zoning ordinances which shall be the primary and dominant bases for the future use of land resources;

RESOLUTION NO. 76-94 - 75-95

WHEREAS, the Proposed Budget of the Municipal Government of General Trias, Cavite, for Calendar Year 1995, was submitted by His Honor, Mayor Teofilo G. Grepo, for consideration and approval of the Honorable Members of the Sangguniang Bayan.

WHEREAS, after a thorough deliberation on the said budget and hearings of the department heads, (including the heads of the national agencies whose functions have been devolved to the local government unit,) resulting to some adjustments of certain appropriations, on motion of SB Member Cornelio A. Grepo, Chair, Committee on Appropriations, duly seconded by all members present, this Body

RESOLVED, as it is hereby resolved, to enact an ordinance appropriating the sum of ₱23,506,374.75 as <sup>33,351,760.01</sup> the Annual Budget of the Municipal Government of General Trias for Calendar Year 1995, to be designated as Appropriation Ordinance No. 11-94 and to be read as follows: <sub>6-95</sub>

APPROPRIATION ORDINANCE NO. 11-94

AN ORDINANCE APPROPRIATING THE SUM OF <sup>33,351,760.01</sup> ₱23,506,374.75 AS THE ANNUAL BUDGET OF THE MUNICIPAL GOVERNMENT OF GENERAL TRIAS FOR CALENDAR YEAR 1995.

Be it enacted by the Sangguniang Bayan of General Trias, duly assembled

- Section 1. - That the amount of <sup>33,351,760.01</sup> ₱23,506,374.75 be appropriated as the Annual Budget of the Municipal Government of General Trias for Calendar Year 1995.
- Section 2. - No money shall be disbursed unless the Municipal Budget certifies to the existence of appropriation that has been legally made for the purpose, the Municipal Accountant has obligated said appropriation and the Municipal Treasurer certifies to the availability of funds for the purpose.
- Section 3. - Disbursement of funds by the Municipal Treasurer shall be based and in accordance with quarterly allotment advice which shall be released by the Municipal Budget Officer ten days before the start of the quarter.
- Section 4. - No money shall be paid out of the local treasury except in pursuance of an appropriation ordinance or law and solely for public purpose.
- Section 5. - Transfer of funds from one department to another shall be approved by the Sangguniang Bayan, and in accordance with budgeting procedures.
- Section 6. - Development projects funded from the 20 percent of the Internal Revenue Allotment (IRA) of the local government shall be approved by the Sangguniang Bayan. A special

account shall be kept by the Municipal Treasurer for the purpose.

- Section 7. - No cash overdraft in any local fund shall be incurred at the end of the calendar year. Overdraft which may be incurred at the end of the calendar year shall be covered with first collection of the immediately succeeding calendar year accruing to such local fund.
  - Section 8. - Funds shall be earmarked monthly by the local municipal treasurer from the monthly IRA of the local government, for the year-end benefits of official and employees which fund shall be deposited with the depository bank as a special account and to be withdrawn only for the purpose intended.
  - Section 9. - The municipal treasurer or municipal accountant shall post an itemized monthly collection and disbursement of funds within 10 days following the end of every month and for at least 2 consecutive weeks and prominent places in the main office building, plaza and main streets, and to publish the said itemization in a newspaper of general circulation, where available, in accordance with Section 413 of the Local Government Code.
  - Section 10.- The municipal treasurer, municipal accountant and municipal budget officer shall, within 30 days from the end of the calendar year, furnish the Sangguniang Bayan with a summary of all revenues collected and funds received during the year from any other sources, including the appropriation disbursement of such funds, as required in Section 352 of the Local Government Code.
  - Section 11.- The municipal treasurer shall furnish the Sangguniang Bayan with a readable copy of monthly trial balance including its schedule.
  - Section 12.- Procurement of supplies and materials shall be in accordance with procedures mandated in Title VI, Book II on Property and Supply Management of the Local Government Code. Austerity in the procurement of office supplies shall be strictly observed.
  - Section 13.- This ordinance shall take effect on January 1, 1995.
