RESOLUTION NO. 10-96

On motion of SB Member Felix A. Grepo duly seconded by all members present, this Body

RESOLVED, to enact an ordinance requiring the issuance of coded business identification plates and/or stickers to some business, commercial and service establishments annually and requiring the display and exhibit of the same and providing penalties for the violation thereof, to be designated as Municipal Ordinance No. 3-96, to read as follows:

MUNICIPAL ORDINANCE NO. 3-96

AN ORDINANCE REQUIRING THE ISSUANCE OF CODED BUSINESS IDENTIFICATION PLATES AND/OR STICKERS TO SOME BUSINESS, COMMERCIAL AND SERVICE ESTABLISHMENTS ANNUALLY AND REQUIRING THE DISPLAY AND EXHIBIT OF THE SAME AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

Section 1. - The herein enumerated business, commercial and service establishments shall be issued with coded business identification plates and/or stickers annually as the case may be.

Section 2. - The size of the coded business identification plates shall be 3" x 8" and the stickers shall be 2" x 4" and shall cost ₱100.00 and ₱50.00 respectively.

Section 3. - The proprietor, manager and/or operator of herein mentioned business, commercial and service establishments shall be required to display their respective coded business identification plates and/or stickers in any conspicuous place in front of their establishments.

Section 4. - PENALTY

1. Any proprietor, manager or operator who has the duty to secure the aforementioned coded business identification plates and/or stickers but fails to secure the same shall, upon conviction thereof, be fined not less than ₱500.00 but not more than ₱1,000.00 or imprisonment of not less than ten (10) days or both at the discretion of the court.
2. Any proprietor, manager or operator who fails to display the coded identification business plates and/or stickers within five (5) days from receipt of the same, shall, upon conviction, be fined not less than ₱500.00 but not more than ₱1,000.00 or imprisonment of not less than ten (10) days upon the discretion of the court.

Section 5. - This ordinance shall take effect upon its approval.
