RESOLUTION NO. 49-97

WHEREAS, there is a need to generate additional fund to support developmental projects of the municipality for human and ecological security;

WHEREAS, Art. 100, Rule XVV of the New Local Government Code of 1991, the approval of subdivision is now devolved to the Local Government Unit;

WHEREAS, under Article 38, Rule VII of the Local Government Code, the municipality through its Sangguniang Bayan as endorsed by the Municipal Development Council may reclassify agricultural land to non-agricultural purposes;

WHEREAS, the imposition of fees is in accordance with Art. 231 of the New Local Government Code of 1991;

WHEREAS, the imposition of penalties for subdivision owner/developer and contractor for industrial or commercial plot will limit illegal conversion and development in the municipality;

WHEREAS, payment of current real property tax due is necessary before granting a permit to develop;

WHEREFORE, on motion of SB Member Luis A. Ferrer IV duly seconded by SB Member Felix A. Grepo,

RESOLVED, to enact an ordinance imposing fees for reclassification, revision, processing of subdivision plan for development and alteration, for building permit-certification of completion and occupancy, penalties for subdivision owner/developer undertaking premature development, to be designated as Municipal Ordinance No. 2-97, to read as follows:

MUNICIPAL ORDINANCE NO. 3-97

AN ORDINANCE IMPOSING FEES FOR RECLASSIFICATION, REVISION, PROCESSING OF SUBDIVISION PLAN DEVELOPMENT AND ALTERATION, FOR BUILDING PERMIT-CERTIFICATION OF COMPLETION AND OCCUPANCY, PENALTIES SUBDIVISION OWNER/DEVELOPER UNDERTAKING PREMATURE DEVELOPMENT.

Be it ordained by the Sangguniang Bayan of General Trias, Cavite, that:

Section 1. - Schedule of Fees

Fees on reclassification, revision and processing of subdivision plan for development and alteration, for building permit-certification of completion and occupancy, penalties for subdivision owner/developer undertaking premature development are hereby imposed, to wit:

a) Reclassification (This is based for the services rendered on processing, reclassify researching, deliberation and issuance of clearance)

Amount of Fee P.1.00/sq. m.of land area to be

b) Revision and processing of subdivision plan for development and alteration

P1,000/hectare

c) For building permitcertification of completion and occupancy

P4.00/sq. m.

Penalties for subdid) P2,000/hectare vision owner/developer P500.00/tree (in and contractor under- excess of more taking premature dev't. than 6" (0.15m) such as soil stripping, in diameter) earthworks, tree cutting

Section 2. - Imposed fee shall be assessed by the Mun. Planning and Development Officer and payment shall be made at the Tresurer's Office before issuance of permit and clearance.

Section 3. - EFFECTIVITY

This ordinance shall take effect upon its approval.
