RESOLUTION ADOPTING PROCLAMATION NO. 60 AND 847 DECLARING THE LAST WEEK OF SEPTEMBER AS FAMILY WEEK AND EVERY FOURTH SUNDAY OF SEPTEMBER AS FAMILY THANKSGIVING DAY.

WHEREAS, Article II, Section 12 of the Constitution of the Philippines provides that "the state recognizes the sanctity of the family life and shall protect and strengthen the family as a basic autonomous social institutions;

WHEREAS, Proclamation No. 60 dated September 28, 1998 declares the last week of September of every year as Family Week and Proclamation No. 847 dated August 12, 1996 declares every fourth Sunday of September of every year as Family Thanksgiving Day;


WHEREAS, the government recognizes the significance of strengthening the Filipino family's unity, solidarity and stability, in view of its socio-economic contributions to national development;


WHEREAS, Executive Order No. 241 orders the creation of a steering committee that shall plan and implement programs and activities to ensure wider and more active participation from the private and public sectors for the nationwide observance of Family Week.
