AMENDING MUNICIPAL ORDINANCE NO. 04-93 (RESOLUTION 56-93) IN GRANTING TAX INCENTIVES TO BUSINESS ENTERPRISES IN GATEWAY BUSINESS PARK BY PROVIDING THE SAME TO OTHER SIMILAR CORPORATIONS, AND REAL ESTATE DEVELOPERS IN THE MUNICIPALITY.

- 1. <u>Incentives to enterprises located in Gateway Business Park and other places in the Municipality of General Trias.</u> Any person, association, partnership, corporation, real estate developer or any other form of business organization which establishes its production, processing or manufacturing plant inside the Gateway Business Park in Gen. Trias, and in other places in the municipality, shall be entitled to the following incentives x x x.
- 2. <u>Applicability</u>. The granting of tax incentives as requested by business entities in writing shall be based on the tremendous benefits the municipality will gain and derive from them as may be determined by the Sanggunian through corresponding resolution;
- 3. <u>Separability Clause</u>. If, for any person, any provision, section, or part of this Ordinance is declared not valid by a Court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections, or parts which shall continue to be in force and effect.
- 4. Repealing Clause. All ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly. This ordinance or any provisions hereof, may in turn, be amended, repealed or otherwise modified only by a special ordinance enacted for the purpose by the Sangguniang Bayan.
  - 5. Effectivity. This ordinance shall take effect upon approval.
