RESOLUTION NO. 04-44 Author : SB Member Carmelito B. Nocon

APPROVING THE CONSTRUCTION OF A COCKPIT IN BARANGAY MANGGAHAN AS REQUESTED BY MR. NESTOR P. SAYON, JR. AND ENACTING AN ORDINANCE GRANTING FRANCHISE FOR ITS OPERATION.

WHEREAS, Article 100 of the Rules and Regulations Implementing the Local Government Code of 1991 (Powers, Duties and Functions of the Sangguniang Bayan) states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions x x x, as provided in Rule IX of these rules, and shall as stated in a Section (3) V of the same rule, subject to the provisions of Book II of this Code, grant franchise, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances levying taxes, fees and charges upon such conditions x x x x and pursuant to this legislative authority that any law to the contrary notwithstanding, authorize and license the establishment, operation and maintenance of cockpits, and regulate cockfighting x x x x that executory rights should be not prejudiced; and also as stated in Section (4) VII, regulate the establishment, operation and maintenance of $x \times x \times x$ places of entertainment or amusement $x \times x \times x$ and such other events or activities for amusement or entertainment, particularly those which tend to disturb the community or annoy the inhabitants, or require the suspension or suppression of the same; or, prohibit certain forms of amusement or entertainment in order to protect the social and moral welfare of the community;

WHEREAS, the proposed location for the cockpit is situated in a highly commercialized area of the municipality;

APPROVING THE CONSTRUCTION OF A COCKPIT IN BARANGAY MANGGAHAN AS REQUESTED BY MR. NESTOR P. SAYON, JR. AND ENACTING AN ORDINANCE GRANTING FRANCHISE FOR ITS OPERATION.

WHEREAS, this body finds no opposition to the proposition of Mr. Sayon regarding the construction of a cockpit and its operation in Barangay Manggahan provided that such business entity shall abide by the promulgated rules and regulations in building construction, specifications, codes, environment and others national directives as well as those that will be imposed by the Local Chief Executive in his power to implement policies in various activities in the municipality as stated in the Local Government Code of 1991;

WHEREFORE, on motion of SB Member Carmelito B. Nocon duly seconded by all Members present, this Body

RESOLVES, AS IT IS HEREBY RESOLVED to approve the construction of a cockpit in Barangay Manggahan as requested by Mr. Nestor P. Sayon, Jr and enacting an ordinance granting franchise for its operation to be known as Municipal Ordinance No. 03 to be read as follows:

MUNICIPAL ORDINANCE 03

GRANTING FRANCHISE TO MR. NESTOR SAYON FOR THE OPERATION OF COCKPIT IN BGY. MANGGAHAN.

Be it enacted by the Sangguniang Bayan that:

Section 1. - The Local Government Unit grants franchise to Mr. Nestor Sayon, Jr. for the operation of a cockpit and operation of such in Barangay Manggahan.

Section 2. - Any activities relative to the operation of the above-cited cockpit shall be in accordance with any existing regulatory acts and other necessary rules and regulations that the Mayor may impose for the proper effective implementation of this ordinance.

Section 3. - Effectivity. The ordinance shall take effect upon its approval.
