ENACTING AN ORDINANCE GRANTING EXEMPTION TO THE "PAMAYANANG MALIKSI MASS HOUSING PROJECT" FROM THE PAYMENT OF CONTRACTOR'S TAX.

WHEREAS, Section 192 of RA 7160 provides that "Local government units may, through ordinances duly approved, grant tax exemptions, incentives or relief under such term and conditions as they may deem necessary;

WHEREAS, the Provincial Local Government of Cavite is embarking on a socialized housing project named "Pamayanang Maliksi" to provide affordable decent home to the low-income, underprivileged and homeless constituents in the municipality;

WHEREAS, public hearings were conducted by this august body to enact an ordinance for this purpose;

WHEREFORE, on motion of SB Member Carlos S. Viniegra II, duly seconded by all Members present, be it,

**RESOLVED, AS IT IS HEREBY RESOLVED** to enact an Ordinance granting exemptions to the "PAMAYANANG MALIKSI MASS HOUSING PROJECT" from the payment of Contractor's Tax, to be designated as Municipal Ordinance No. 08-06, to be read as follows:

### MUNICIPAL ORDINANCE NO. 08-06

AN ORDINANCE GRANTING EXEMPTIONS TO THE PAMAYANANG MALIKSI MASS HOUSING PROJECT FROM THE PAYMENT OF CONTRACTOR'S TAX.

### Section 1. COVERAGE

The exemption from the payment of contractor's tax herein granted shall apply exclusively within the territorial jurisdiction of the Municipality of General Trias in conjunction with the Pamayanang Maliksi Mass Housing Project.

#### Section 2. EFFECTIVITY

This Ordinance shall take effect fifteen (15) days after its posting in the conspicuous places in the municipality.

**RESOLVED FURTHER**, that copies of this resolution be provided to concerned offices for information and appropriate action.
