RESOLUTION ENACTING THE REVISED GENERAL TRIAS TRAFFIC CODE OF 2008.

WHEREAS, to address all traffic and parking concerns of the municipality, Municipal Ordinance No. 05-96 was passed for the purpose of regulating and implementing all traffic rules and regulations;

WHEREAS, in view of the fast changing developments and progress in the Municipality of General Trias, in terms of volume of population, infrastructure, volume of vehicles, and modes of transportation, it is deemed necessary and proper to come up with an ordinance uniform in scope to address traffic problems in the municipality;

WHEREFORE, on motion of SB Member Noel A. Morena, duly seconded by SB Member Maurito C. Sison, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution enacting the Revised General Trias Traffic Code of 2008, to be designated as Municipal Ordinance No. 08-09 and to read as follows:

MUNICIPAL ORDINANCE NO. 08-09

Be it ordained by the Sangguniang Bayan of General Trias, Cavite, that:

Section 1. TITLE. This Ordinance shall be known as the “**REVISED GENERAL TRIAS TRAFFIC CODE OF 2008**”.

Section 2. SCOPE AND APPLICATION. This Ordinance provides for the traffic rules and regulations on all roads in the municipality and shall be applicable within the territorial jurisdiction of the Municipality of General Trias.

Section 3. DEFINITION OF TERMS.

- a. Driver - any person having control of the directional and motive power of a vehicle.
- b. Intersection - the place at which two or more roads cross.
- c. Motor Vehicle - conveyance designed to be self-propelled, and includes any vehicle designated to be propelled by electric power obtained from overhead wires but not operated upon rails.
- d. No Parking Area - the portion of a thoroughfare between two consecutive “No Parking” signs and with arrows pointing generally towards each other or other appropriate signs.
- e. One-way Thoroughfare - a thoroughfare on which a vehicle is permitted to travel in one direction only, as indicated by appropriate

signs or signals.

- f. Parking Area - the portion of the thoroughfare where parking is permitted as indicated by appropriate notices or parking signs.
- g. Pedestrian - any person on foot or in a perambulator.
- h. Public Motorized Tricycle - a motor vehicle composed of a motorcycle fitted with a single-wheeled side car operated to render transport service to the general public for fees.
- i. Reckless Driving - the manner of driving which fails to take care under circumstances that may cause harm or injury to a person or property. It is the driver's duty to avoid injury to person or property.
- j. Road - a part of land surface designed or used for the passage of vehicles, whether motorized or not, inclusive of sidewalks and shoulders forming part of the right of way, sometimes called street or highway.
- k. Seating Capacity – one (1) for driver and one (1) for passenger in a single motorcycle, one (1) for driver and four (4) for passengers in ordinary tricycles and one (1) for driver and six (6) for passengers in a back to back tricycles.
- l. U-turn - a movement which causes a vehicle facing or traveling in one direction to face or travel in the opposite, or substantially the opposite direction.
- m. Thoroughfare - the portion of a road improved, designed or used for vehicular travel exclusive of the shoulder and footway
- n. Traffic Sign – any appropriate traffic device, symbol, or sign erected along the roads that provides information or guidance to road users and travelers.

Section 4. DESIGNATED ROUTES.

4.1. PUBLIC UTILITY JEEPNEYS FROM PALA-PALA GOING TO TEJERO

From Bgy. Sta. Clara shall pass Sta. Clara Bridge; shall be going to the direction of Bonifacio St.; shall traverse the entire road of Bgy. San Juan; going straight to Bgy. Tejero.

4.2. PUBLIC UTILITY JEEPNEYS FROM TEJERO GOING TO PALA-PALA

From Bgy. Tejero shall pass the entire road of Bgy. San Juan; shall go by the entire Bonifacio St.; shall cross Sta. Clara Bridge; proceed straight.

4.3. PUBLIC UTILITY JEEPNEYS FROM MANGGAHAN GOING TO MALABON

From Bgy. Prinza shall pass Bonifacio St. Crossing; shall go by the entire Gov. Ferrer Ave.; shall reach Bgy. Sampalucan; turn left going to market road/parking area; going to San Juan By-Pass road; turn left going to Bgy. San Juan I road; pass Bonifacio St.; and turn left to Bgy. Prinza Terminal.

4.3.1. An area in the public market is temporarily designated for jeepneys with the foregoing route as the parking area.

4.4. PUBLIC UTILITY JEEPNEYS FROM CAVITE CITY AND VICE-VERSA

From Bgy. San Juan shall pass Bonifacio St. Crossing; shall pass the entire Gov. Ferrer Ave.; shall reach Bgy. Sampalucan; turn left to market road; turn right to parking area; shall proceed to Corregidor St.; turn left to Bgy. Sampalucan; proceeding to terminal at the side of St. Francis of Assisi Parish Church.

4.4.1. An area in the public market is temporarily designated for jeepneys with the foregoing route as the parking area.

4.5. CARGO TRUCKS AND ANY OTHER DELIVERY TRUCKS COMING FROM TEJERO GOING TO PUBLIC MARKET

From Bgy. Tejero shall pass Bgy. San Juan II and I; shall pass Bonifacio St. Crossing; shall go by the entire Gov. Ferrer Ave.; shall reach Bgy. Sampalucan; turn left going to market road.

4.5.1. Cargo trucks and other delivery trucks shall not be allowed to use Corregidor St. as their exit point.

Section 5. LOADING AND UNLOADING STATIONS.

5.1. PUBLIC VEHICLES FROM PALA-PALA GOING TO TEJERO

- a. At the foot of Sta. Clara Bridge parallel to Fil-Oil Gasoline Station
- b. Between San Juan Bridge and San Juan I Barangay Hall

Section 6. SPEED RESTRICTION.

6.1. ALL ROADS WITHIN THE PREMISES OF ALL BARANGAYS WITHIN THE TOWN PROPER. (Bgy. Prinza, Gov. Ferrer, 1896, Arnaldo, Corregidor, Vibora, Bagumbayan, Sampalucan, San Gabriel and Dulong Bayan)

No person shall drive a vehicle at a speed exceeding 20 kph on the streets indicated herein. (Municipal Ordinance No. 05-96, par. 5)

Section 7. TRUCK BAN AND LIMITED TRUCK BAN.

7.1. CARGO TRUCKS AND ANY OTHER DELIVERY TRUCKS WITH TEN TO EIGHTEEN WHEELS.

Said trucks shall be restricted to travel on any major thoroughfares and/or streets of the Municipality of General Trias from the hours of six o'clock (6:00 am) to nine o'clock in the morning (9:00 am) and from three o'clock in the afternoon (3:00 pm) to seven o'clock in the evening (7:00 pm) as per Municipal Ordinance No. 02-97.

7.3. PENALTIES

A fine of One Thousand Pesos (Php 1,000.00) or imprisonment of not more than five (5) days or both upon the discretion of the court.

7.4. PAYMENT OF FINES/PENALTIES

The penalties imposed shall be paid directly to the Office of the

Municipal Treasurer as evidenced by a corresponding receipt.

Section 8. COLOR CODING

To control the volume of all public motorized tricycles in the Municipality of General Trias plying within their respective routes, color coding is hereby applied.

8.1. APPLICATION OF COLOR CODING

- a. No public motorized tricycles with the YELLOW color code sticker shall be allowed to ply on Monday;
- b. No public motorized tricycles with the BLUE color code sticker shall be allowed to ply on Tuesday;
- c. No public motorized tricycles with the RED color code sticker shall be allowed to ply on Wednesday;
- d. No public motorized tricycles with the ORANGE color code sticker shall be allowed to ply on Thursday; and
- e. No public motorized tricycles with the GREEN color code sticker shall be allowed to ply on Friday.

8.2. EXEMPTION

Color coding shall not be applied on Saturdays, Sundays and during emergency cases.

8.3. PENALTIES

A fine of Three Hundred Pesos (Php 300.00) shall be imposed to operators/drivers of public motorized vehicles found violating this provision.

8.4. PAYMENT OF FINES/PENALTIES

The penalties imposed shall be paid directly to the Office of the Municipal Treasurer as evidenced by a corresponding receipt.

Section 9. FINES/PENALTIES FOR TRAFFIC VIOLATIONS, MANNER OF PAYMENT AND PROVIDING INCENTIVES TO PERSONS DULY AUTHORIZED BY LAW.

Despite existing Municipal Ordinance No. 05-96 Sub-section 8, providing for fines/penalties imposed for violation of traffic rules within the Municipality of General Trias, it has been observed that many motorists continue to commit such violations.

9.9. PAYMENT OF FINES/PENALTIES

All fines/penalties payable shall be paid directly to the Office of the Municipal Treasurer which transaction shall be evidenced by a corresponding official receipt.

In case of failure to appear or settle penalties within the prescribed period of five (5) days a five percent (5%) per day surcharge shall be added and appropriate court action shall be instituted for unredeemed licenses beyond thirty (30) days.

9.10. INCENTIVES

Designated Traffic Aides authorized to implement this Ordinance shall be entitled to ten percent (10%) of all fines/penalties collected therein.

Section 10. SEPARABILITY CLAUSE.

If for any reason, any section or provision of this Ordinance is declared illegal or unconstitutional other sections or provisions hereof which are not affected thereby shall continue to be in full force or effect.

Section 11. REPEALING CLAUSE.

All previous issuances, ordinances, rules and regulations or parts thereof which are inconsistent or in conflict with the provision of this Code are hereby repealed or modified accordingly however, existing ordinances which are not inconsistent shall remain in full force.

Section 12. EFFECTIVITY.

This Ordinance shall take effect fifteen (15) days after its approval and after its posting in three (3) conspicuous places in the municipality.


