CONSIDERATELY EXTENDING THE SCHEDULE OF PAYMENT OF BUSINESS TAXES AND FEES WITHOUT SURCHARGE AND PENALTIES IN THE MUNICIPALITY OF GENERAL TRIAS UNTIL 06 FEBRUARY 2015.

WHEREAS, the local government has always been generous in extending kind consideration to its taxpayers taking into account the different untoward and unusual situations the taxpayers may meet;

WHEREAS, it is but morally upright to give devout taxpayers ample considerations for the best interest of both the taxpayers and the local government;

WHEREAS, to increase the revenue collection and improve its system, certain considerations should be given to taxpayers;

WHEREAS, Chapter 3, Section 167 of the Local Government Code of 1991 provides that the Sanggunian may, for a justifiable reason or cause extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

Section 1. - TITLE. Considerately Extending the Schedule of Payment of Business Taxes and Fees Without Surcharge and Penalties in the Municipality of General Trias Until 06 February 2015.
