AN ORDINANCE PROVIDING THE RATES AND OTHER FEES IN THE USE OF GENERAL TRIAS SPORTS COMPLEX, GENERAL TRIAS CULTURAL AND CONVENTION CENTER, AND GENERAL TRIAS SPORTS PARK.

WHEREAS, General Trias Sports Complex, General Trias Cultural and Convention Center, and General Trias Sports Park are the municipality's foremost amenities that support the social, civic, cultural, and recreational needs of the people;

WHEREAS, the rates, fees, and other charges in the use of the aforementioned amenities are directly tied to the cost of their maintenance and repair;

WHEREAS, to provide and sustain a good quality and standard services to its people, the Local Government Unit has devised a set of guidelines on the collection of fees and rates in the use of the said amenities;

Section 1. TITLE - This Ordinance shall be known as the General Trias Sports Complex, General Trias Cultural and Convention Center, and General Trias Sports Park Rates and Fees Ordinance.

## Section 2. PAYMENT SCHEME, RATES AND FEES.

The payment scheme, rates and fees in using General Trias Sports Complex, General Trias Cultural and Convention Center, and General Trias Sports Park are as follows:

### A. General Trias Cultural and Convention Center

- I. Php3,000.00 per hour in the use of the facility including the use of its air conditioning system.
- II. Php1,500.00 per hour in the use of the facility excluding the use of its air conditioning system.
- III. Php5.00 per unit for monobloc chair use.
- IV. Corkage fee of Php5,000.00.
- V. Php500.00 fee for minimum load of electricity for lighting and sound system.

### B. General Trias Sports Center

- I. Php600.00 per hour for evening games.
- II. Php300.00 per hour for daytime games.

### C. General Trias Sports Park

- I. Oval, Steeple Chase, Pole Vault, and Triple Long Jump





**Section 3. OTHER GUIDELINES AND POLICIES - The following shall be observed on the use of facilities at Sports Park:**


1. **Joggers are charged Php10.00 per head.**
2. **Municipal Employees, Barangay Officials & Appointed Barangay Employees, Senior Citizens, Persons with Disabilities and all employed and enrolled in public schools can jog in the General Trias Sports Park for free subject to prescribed operating hours.**
3. **All employees of the Local Government Unit of General Trias are free to use all the facilities in the General Trias Sports Park upon presentation of LGU IDs.**
4. **Athletes who represent General Trias to sporting events can use the facilities of General Trias Sports Park for free subject to prescribed operating hours.**
5. **In case a conflict of schedule between a public and a private event occurs, the public event will be given priority.**
6. **Public schools in General Trias can use the facilities of General Trias Sports Park for events free of charge upon presentation of a letter confirming the said event.**
7. **The Local Chief Executive has the authority to give discounts to individuals who would want to use the facilities of Convention Center, Sports Complex, and Sports Park.**
8. **The Local Chief Executive has the authority to order closure of the Sports Park if necessary.**

**Section 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect in the next ensuing quarter after copies of which have been published in a local newspaper if there is any or posted in the bulletin board at the entrance of the Municipal Hall or in at least two (2) conspicuous places within the Municipality of General Trias.**




