TEMPORARILY CLOSING THE VIBORA-STA. CLARA ACCESS ROAD FOR THE CONSTRUCTION OF A NEW CONNECTING BRIDGE THEREAT UNTIL DECEMBER 2024.

WHEREAS, the infrastructure project of the Department of Public Works and Highways (DPWH) is expected to bring many benefits to the City assuring the residents of an improved and more durable concrete bridge that facilitates smooth transportation system;

WHEREAS, it is necessary to demolish the existing overflow bridge between Barangay Vibora and Barangay Sta. Clara which is highly vulnerable to extreme flooding and be replaced with a stronger connecting bridge for enhanced mobility providing commuters and vehicles in the City a safer and more efficient transport route;

WHEREAS, it is highly recommended to temporarily close the Vibora-Sta. Clara access road to eliminate the exposure of motorists on the work zone, minimize casualties brought about by falling debris, allow contractors full access to the bridge facilities, and effectively carry out the ongoing construction thereat;

WHEREAS, Section 21(a) of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, temporarily close any local road;

WHEREAS, the Sanggunian deemed it necessary to temporarily close the Vibora-Sta. Clara access road to pave the way for the DPWH infrastructure project;

NOW THEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member Felix A. Grepo,

Be it enacted by the Sangguniang Panlungsod, that:

Section 1. TITLE – This Ordinance shall be known as the “TEMPORARY CLOSURE OF VIBORA-STA. CLARA ACCESS ROAD ORDINANCE”.

Section 2. REGULATED ACTS – The Vibora-Sta. Clara access road shall be temporarily closed until December 2024 for the completion of the bridge construction project thereat.

TEMPORARY CLOSURE OF VIBORA-STA. CLARA ACCESS ROAD ORDINANCE.


Coordination with the Office of the City Mayor and City Traffic Management and Public Safety Section for their information shall be made regarding the traffic situations along the said area during the prescribed period.

SECTION 3. PROVISION – During the road closure, all vehicles are encouraged to take any possible alternate route to avoid traffic congestion and delay.

Section 4. EFFECTIVITY CLAUSE – This Ordinance shall take effect upon its approval.






