**AMENDING SECTIONS 3 AND 7 OF CITY ORDINANCE NO. 17-03 (GENERAL)  
OTHERWISE KNOWN AS THE CITY ANTI-DENGUE COUNCIL.**

**WHEREAS, the Sangguniang Panlungsod of General Trias enacted City Ordinance No. 17-03 on 07 February 2017 creating the City Anti-Dengue Council;**

**WHEREAS, on 06 August 2017, the Department of Health (DOH) declares dengue as a national epidemic occurring all year round in the country, hence, calling the attention of the Local Government Units to heighten the awareness of the community and focus on 4S: Search and destroy the mosquito breeding sites, Self-protection measures, Seek early consultation and, Support fogging/spraying in hotspot areas;**

**WHEREAS, to increase the responsiveness of the City Government, to the call of the DOH, there is a need to amend the composition under Section 1 of the above-mentioned ordinance to include the office and officials' helpful in endorsing the concern on dengue and Section 7 thereof;**

**WHEREFORE, on motion of SP Member Kristine Jane M. Perdito-Barison duly seconded by SP Member Vivencio Q. Lozares, Jr.,**

**BE IT ENACTED by the Sangguniang Panlungsod, that:**




