GRANTING CASH INCENTIVE OF FIVE THOUSAND PESOS (PHP 5 000.00) TO ANY SENIOR CITIZEN IN THE CITY OF GENERAL TRIAS WHO IS 80 TO 89 YEARS OLD UPON THE EFFECTIVITY OF THIS ORDINANCE AND THOSE WHO WILL REACH THE AGE OF 80 YEARS OLD THEREAFTER.

WHEREAS, the City of General Trias recognizes the role of senior citizens to nation-building and reaffirms the valued Filipino tradition of taking care of the elderly pursuant to Republic Act No. 9994 otherwise known as the Expanded Senior Citizens Act of 2010;

WHEREAS, in consideration of the above provisions and in appreciation of the senior citizens' contribution to the society, the Sangguniang Panlungsod deemed it proper and appropriate to grant cash incentive amounting to Five Thousand Pesos (Php 5 000.00) to any senior citizen in the City of General Trias who is 80 to 89 years old upon the effectivity of this Ordinance and those who will reach the age of 80 thereafter;

WHEREFORE, on motion of SP Member Jowie S. Carampot duly seconded by SP Member Walter C. Martinez,

BE IT ENACTED by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as the "CASH INCENTIVE TO 80-89 YEARS OLD SENIOR CITIZENS ORDINANCE".

SECTION 2. SCOPE AND REQUISITES - Any resident of the City of General Trias aged 80-89, presently residing in the City of General Trias for at least 5 years if born in General Trias or at least 10 years if not born in General Trias and duly certified by the Punong Barangay where he/she resides, shall be qualified for the cash incentive of Php 5 000.00.

In addition to the aforementioned barangay certification, the awardee shall provide at least one (1) of the following documents:

- a. Certificate of Birth duly certified by the Local Civil Registrar where the awardee was born and/or by the Philippine Statistics Authority,**

(Note: Late registration is allowed as long as it is duly certified by the Local Civil Registrar or by the Philippine Statistics Authority),

- b. Certificate of Marriage duly certified by the Local Civil Registrar and/or by the Philippine Statistics Authority,
- c. Baptismal Certificate, and
- d. Valid Identification Documents (Government-issued ID, Passport, etc.).

The aforementioned requirements shall be submitted for assessment and verification to the committee formed by the Office of the City Mayor as stated in Section 5.

SECTION 3. EXEMPTIONS AND OTHER CONSIDERATIONS -

- a. Any senior citizen currently residing in the City of General Trias before the passage and approval of this Ordinance, who is between 76-79 years of age, that will reach the age of 80 years old shall be eligible to receive a cash incentive mentioned in Section 4 of this ordinance regardless of the birthplace (whether the subject awardee was born or not in General Trias), and
- b. Any senior citizen currently residing in the City of General Trias before the passage and approval of this Ordinance, who has reached the age of 80-89 years old, is automatically eligible to receive a cash incentive mentioned in Section 4 of this Ordinance regardless of the birthplace (whether the subject awardee was born or not in General Trias).

SECTION 4. CASH INCENTIVE - Any senior citizen residing in the City of General Trias who is 80 to 89 years old upon the effectivity of this Ordinance and those who will reach the age of 80 years old thereafter shall receive a cash gift amounting to Five Thousand Pesos (Php 5 000.00) after conforming to Section 3.

SECTION 5. IMPLEMENTING AGENCY - The Office of the City Mayor shall form and spearhead a committee in coordination with the Office of the Senior Citizens Affairs (OSCA), the City Social Welfare and Development Office (CSWDO) and the Sangguniang Panlungsod Committee on Elderly to execute this Ordinance.

SECTION 6. EFFECTIVITY - This Ordinance shall take effect immediately upon completion of its publication in a local newspaper of general circulation or after posting in the lobby of the City Hall Building and in every barangay hall within the City of General Trias.


