





**AN ORDINANCE LIFTING CITY ORDINANCE NO. 21-06 OTHERWISE KNOWN AS THE "SUSPENSION OF COLLECTION OF PAYMENTS ORDINANCE DURING COVID-19 PANDEMIC PERIOD".**

**WHEREAS, the City Government of General Trias through the Sangguniang Panlungsod enacted City Ordinance No. 21-06 otherwise known as the "Suspension of Collection of Payments Ordinance During COVID-19 Pandemic Period", aimed to ease the burden of its constituents concerning financial matters due to negative impact of COVID-19 pandemic;**

**WHEREAS, President Ferdinand R. Marcos Jr. issued Proclamation 297, lifting the nationwide declaration of State of Public Health Emergency due to COVID-19 thus all prior orders, memoranda, and issuances that are effective only during the State of Public Health Emergency shall have been deemed withdrawn, revoked or cancelled and shall no longer be in effect;**

**WHEREAS, to recoup the operating expenses incurred in rendering some services in the City and to aid in financing these services, the City Ordinance No. 21-06 must be lifted;**

**NOW THEREFORE, on motion of SP Member Felix A. Grepo duly seconded by SP Member Kristine Jane M. Perdito-Barison,**

**Be it enacted by the Sanggunian, that:**

**Section 1. TITLE - This Ordinance shall be known as "LIFTING OF THE SUSPENSION OF COLLECTION OF SOME PAYMENTS IN THE CITY DUE TO COVID-19 PANDEMIC ORDINANCE".**

**Section 2. City Ordinance No. 21-06: Suspending the Collection of Payments for Mayor's Permit in Securing Employment, Occupation/Calling Not Requiring Government Examination, Medical Certificate/Health Card, Transfer of Cadaver, and Opening of Niche during Coronavirus Disease 2019 (COVID-19) Pandemic Period, is hereby lifted.**

**Section 3. EFFECTIVITY - This Ordinance shall take effect immediately after approval.**
