CONSIDERATELY EXTENDING THE SCHEDULE OF PAYMENT OF BUSINESS TAXES AND FEES WITHOUT SURCHARGE AND PENALTIES IN THE CITY OF GENERAL TRIAS UNTIL 05 FEBRUARY 2016.

WHEREAS, the City Treasurer and Licensing Officer observe the following problems that need to be addressed during taxes and fees payment period:

1. Increasing number of business establishments,
2. Bulk of business permit applicants and taxpayers during the renewal period,
3. Lack of time for the business taxpayers to assess finances due to high operational and personal expenses in December,
4. Slower performance of the computerized business permit and licensing system in January due to simultaneous encoding of data in the server,
5. Inadequate time for the taxpayers to process papers and documentary requirements,
6. Insufficient time for the concerned local government personnel to assess sales declaration of taxpayers as well as proper requirements, and
7. Need for modification and updating of the requested computers and printers;

WHEREAS, the city government has been consistent in considering unavoidable circumstances which may interfere with the taxpayer's ability to settle taxes on time;

WHEREAS, kind considerations extended to the taxpayers shall both benefit the taxpayers and the city government;

WHEREAS, the giving of considerable longer time for settlement of taxes shall undoubtedly increase the city's revenue collection and as a consequence generate a positive result to the community;

WHEREAS, Chapter 3, Section 167 of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for a justifiable reason or cause, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin, SP Member Gary A. Grepo, SP Member Jowie S. Carampot, SP Member Kerby J. ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:


Section 1. TITLE. The Sanggunian considerably extends the schedule of payment of business taxes and fees without surcharge and penalties in the City of General Trias until 05 February 2016. This will be known as "Extended Schedule of Tax and Fees Payment" Ordinance.

Section 2. EFFECTIVITY CLAUSE. This Ordinance shall take effect after posting of copies in conspicuous places in the city has been undertaken.
