SEPARATING GOVERNOR FERRER MEMORIAL NATIONAL HIGH SCHOOL-BUENAVISTA (GFMNHS-ANNEX) FROM ITS MOTHER SCHOOL, THE GOVERNOR FERRER MEMORIAL NATIONAL HIGH SCHOOL (GFMNHS-MAIN) AND NAMING IT ANDRES A. NOCON NATIONAL HIGH SCHOOL IN RECOGNITION OF THE BENEVOLENCE OF THE SAID DONOR OF THE PARCEL OF LAND WHERE THE SCHOOL IS ERECTED.

WHEREAS, in the letter-request of the Head Teacher of Governor Ferrer Memorial National High School-Buenavista (GFMNHS-Annex), Mrs. Melinda A. Tapawan to the Sangguniang Panlungsod, she reiterated her concern and reasons for the separation and independence of the said school from the cluster of schools under Governor Ferrer Memorial National High School (GFMNHS-Main);

WHEREAS, in accordance to DepEd Order No. 40 titled "Establishment, Merging, Conversion, and Naming/Renaming of the Public Schools Annexes in Basic Education", the renaming of a school requires a Sangguniang Panlungsod ordinance supporting the matter before it is given recognition to an independent public education institution;

WHEREAS, it is but fitting to give due recognition to the donor of the school site much to the request of the donor's family;

WHEREAS, the Sangguniang Panlungsod believes that the independence of Ferrer Memorial National High School-Buenavista (GFMNHS-Annex) shall benefit a number of the young Gentriseños specially those living in the same barangay and nearby areas;

WHEREFORE, on motion of SP Member Vivencio Q. Lozares, Jr. duly seconded by SP Member Jonas Glyn P. Labuguen, SP Member Kerby J. Salazar, SP Member Christopher N. Custodio, SP Member Walter C. Page 2 of City Ordinance No. 16-09 (Special):


