GRANTING CASH INCENTIVE OF TEN THOUSAND PESOS (PHP 10 000.00) TO ANY SENIOR CITIZENS IN THE CITY OF GENERAL TRIAS WHO ARE 90 TO 99 YEARS OLD UPON THE EFFECTIVITY OF THIS ORDINANCE AND THOSE WHO WILL REACH THE AGE OF 90 YEARS OLD THEREAFTER.

WHEREAS, pursuant to Article XV, Section 4 of the 1987 Philippine Constitution, it is the duty of the family to take care of its elderly members while the State may design programs of social security for them;

WHEREAS, pursuant also to RA No. 9994, Section 2 (d), the City of General Trias encourages its families and communities they live with to reaffirm the valued Filipino traditions of caring for the senior citizens;

WHEREAS, in consideration of the above provisions and in appreciation of the role of the senior citizens in nation-building, the Sangguniang Panlungsod deemed it proper and appropriate to grant cash incentive amounting to Ten Thousand Pesos (Php 10 000.00) to any senior citizens in the City of General Trias who are 90 to 99 years old upon the effectivity of this ordinance and those who will reach the age of 90 thereafter.

NOW THEREFORE, on motion of SP Member Jowie S. Carampot duly seconded by SP Member Hernando M. Granados, SP Member Florencio D. Ayos, SP Member Walter C. Martinez, SP Member Christopher N. Custodio, SP Member Kerby J. Salazar, SP Member Jonas Glyn P. Labuguen, SP Member Gary A. Grepo, SP Member Mario C. Amante, SP Member Vivencio Q. Lozares, Jr. and SP Member Constanca S. Felizardo,

Be it enacted by the Sangguniang Panlungsod of the City of General Trias, that:

Section 1. TITLE - GRANTING CASH INCENTIVE OF TEN THOUSAND PESOS (Php10 000.00) TO ANY SENIOR CITIZENS IN THE CITY OF GENERAL TRIAS WHO ARE 90 TO 99 YEARS OLD UPON THE EFFECTIVITY OF THIS ORDINANCE AND THOSE WHO WILL REACH THE AGE OF 90 YEARS OLD THEREAFTER.

Section 2. REQUISITES - Any resident of General Trias aged 90-99, presently residing in General Trias for at least 5 years if born in General Trias or at least 10 years if not born in General Trias or certified by the Punong Barangay shall be qualified for the financial reward of Php 10 000.00.

Page 2 of City Ordinance No. 16-13 (Special):

In addition to the aforementioned barangay certification, the awardee shall provide at least one of the following documents:

- a. Certificate of Birth duly certified by the Local Civil Registrar where the awardee was born and/or by the Philippine Statistics Office;
(Note: Late registration is allowed as long as it is duly certified by the Local Civil Registrar and/or by the Philippine Statistics Office)
- b. Certificate of Birth of the child(ren) duly certified by the Local Civil Registrar where the awardee was born and/or by the Philippine Statistics Office;
- c. Certificate of Marriage duly certified by the Local Civil Registrar and/or by the Philippine Statistics Office;
- d. Baptismal certificate;
- e. Valid Identification (Gov't issued ID, Passport, etc.).

The aforementioned requirements shall be submitted for assessment and verification to the committee formed by the Office of the City Mayor in Section 5.

Section 3. SCOPE AND COVERAGE -

- a. Any Gentriseño currently residing in General Trias before the passage and approval of this ordinance, who is between 86-89 years of age, that will reach the age of 90 years old shall be eligible to receive a cash incentive mentioned in Section 4 of this ordinance regardless of the birthplace (whether the awardee was born or not in General Trias).
- b. Any Gentriseños currently residing in General Trias before the passage and approval of this ordinance, who has reached the age of 90-99 years old, is automatically eligible to receive a cash incentive mentioned in Section 4 of this ordinance regardless of the birthplace (whether the subject awardee was born or not in General Trias).

Section 4. CASH INCENTIVE - Any Gentriseño who is 90 to 99 years old upon the effectivity of this ordinance and those who will reach the age of 90 years thereafter shall receive a cash gift amounting to Ten Thousand Pesos (Php 10 000.00) after conforming to Section 3.

Section 5. IMPLEMENTING AGENCY - The Office of the City Mayor shall form and spearhead a committee in coordination with the Office of Senior Citizens Affair, the City Social Worker and Development Office and the Sangguniang Panlungsod Committee on Elderly to execute this Ordinance.

Section 6. SEPARABILITY CLAUSE - If for any reason(s), any part of this ordinance is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby, shall continue in full force and effect.

Section 7. EFFECTIVITY - This Ordinance shall take effect on January 2017 and upon completion of its publication in a local newspaper of general circulation or posting it in the lobby of the City Hall and in every barangay hall within the City of General Trias.




