EXTENDING THE DEADLINE FOR THE PAYMENT OF TAXES, FEES, AND CHARGES IN THE CITY OF GENERAL TRIAS UNTIL 20 JUNE 2020 WITHOUT PENALTIES, SURCHARGES, OR INTEREST DUE TO THE OUTBREAK OF CORONAVIRUS DISEASE 2019 (COVID-19).

WHEREAS, the Local Chief Executive in his letter to the Sanggunian dated 31 March 2020, requested the passage of an ordinance extending the deadline of payments and suspending the imposition of penalties, interests and surcharges in the revenue-generating activities in the City to give taxpayers much needed reprieve given the current situation;

WHEREAS, considering the limitation of time for the taxpayers to pay taxes, fees and other charges due to the implementation of the Enhanced Community. Quarantine in view of the outbreak of Coronavirus Disease 2019 (COVID-19), there is an imperative need to extend the deadline for the payment of the said obligations;

WHEREAS, in the interest of the positive relationship between the City Government and the taxpayers, the deadline for payment of taxes, fees, and other charges should be extended until 20 June 2020 without penalties, surcharges, or interests for the First and Second Quarters;

WHEREAS, Section 167 of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for justifiable reason or cause, extend the time for payment of unpaid taxes without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin,

Be it ordained by the Sangguniang Panlungsod in Regular Session α

SECTION 1. COVERAGE - All annual and quarterly taxes, fees, and charges which is due and payable to the City Government for the First and Second Quarters of the current year can be paid not later than 20 June 2020 without penalties, surcharge, or interest.

SECTION 2. PENALTIES AND INTEREST – All taxes, fees, and charges due for the First and Second Quarters of the current year shall, however, be subject to

SECTION 3. REPEALING CLAUSE – Any provisions of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended, or modified accordingly.

SECTION 4. EFFECTIVITY - This Ordinance shall take effect immediately upon its approval.
