MANDATING SHUTTLE BUS SERVICE TO LOAD AND UNLOAD PASSENGERS IN FRONT OF THEIR RESPECTIVE HOUSES OR GATES OF SUBDIVISIONS IN THE CITY OF GENERAL TRIAS DURING THE IMPOSITION OF ENHANCED COMMUNITY QUARANTINE (ECQ).

WHEREAS, Presidential Proclamation No. 922 series of 2020 was issued by President Rodrigo Roa Duterte declaring a State of Public Health Emergency throughout the Philippines due to Coronavirus Disease 2019 (COVID-19) which enjoins all government agencies and Local Government Units (LGUs) to render full assistance and cooperation in this time of national health crisis;

WHEREAS, based on the Department of Transportation's (DOTs) Guidelines on the Social Distancing and Community Quarantine, pursuant to the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-EID) Resolution No. 12 series of 2020, the local government units are directed to adopt, coordinate and implement guidelines for all types of motor vehicles during the implementation of Enhanced Community Quarantine (ECQ);

WHEREAS, Labor Advisory No. 11 series of 2020 under Department of Labor and Employment (DOLE) entitled as "Supplementary Guidelines Relative to Remedial Measures in View of the Ongoing Outbreak of Coronavirus Disease 2019", guidelines are hereby issued to help ensure containment of COVID-19 transmission through adoption of flexible work arrangements and observance of strict distancing measures;

NOW THEREFORE, on motion of SP Member Isagani L. Culanding duly seconded by SP Member Florencio D. Ayo,

Be it enacted by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as the "Shuttle Bus Service Loading and Unloading Zones."

SECTION 2. DECLARATION POLICY - It is hereby declared the policy of the City of General Trias to coordinate and regulate the guidelines aligned in the implementation of Enhanced Community Quarantine (ECQ) within the City to prevent containment, transmission of the pandemic disease and ensure the safety of its people.

Continuation...page 2 of City Ordinance No. 20-22 (General):

SECTION 3. COVERAGE -

- a. Shuttle bus services are prohibited to load and unload passengers in any place in the city during the imposition of Enhanced Community Quarantine (ECQ),
- b. All factories or corporations are mandated to direct their Shuttle Bus Services to load and unload employees right in front of their respective residences or gates of subdivisions in order to prevent passengers in converging in crowded places,
- c. Shuttle Bus Services should have passengers not more than half of their regular capacity including the driver in any trip,
- d. Residents reporting for work that will be accommodated by the Shuttle Bus Services shall present proof of employment such as Identification (ID) card containing the company address, place of work and employee's location of residency or Certification of employment issued by the company which shall state the place of work.

SECTION 4. PENALTIES - Any driver/violator of this Ordinance shall be meted the following penalties:

First Offense : Reprimand, and
Second Offense : Community service

SECTION 5. IMPLEMENTING RULES AND REGULATIONS - This Ordinance shall be implemented by the Office of the City Mayor, Personnel of General Trias City Police, City Traffic Management Office (CTMO), Barangay Officials and other offices or personnel as may be deputized by the Local Chief Executive.


SECTION 6. REPEALING CLAUSE - All orders, memoranda, rules and regulations, or any part of parts hereof, inconsistent with the provisions of this ordinance are hereby revoked or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE - If for any reason a provision of this Ordinance is declared invalid or unconstitutional, all other provisions hereof not affected thereby shall continue to be in full force and effect.


SECTION 8. EFFECTIVELY CLAUSE - This Ordinance shall take effect upon approval.


