**PROVIDING INCENTIVES TO ESTABLISHMENTS THAT PROVIDED ACCOMMODATION FOR THE HEALTH WORKERS DURING THE CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC, AND APPROPRIATING FUNDS THEREFOR.**

**WHEREAS, the health workers, in the continuous battle with Coronavirus Disease 2019 (COVID-19), risk their lives to protect the people, and give them proper care and medication;**

**WHEREAS, in the diligent performance of their duties in this time of great adversity, the health workers are placed at a higher risk in hazardous conditions, subjected to difficulties in accessing transportation to and from the workplaces, financial stress, discrimination, and an added degree of worrying about having contracted the virus and of fear transmitting it to their family members especially the vulnerable ones;**

**WHEREAS, recognizing that the health workers are extremely vital in playing the crucial role in the fight against COVID-19, any help extended to alleviate their sufferings and anxieties is considered a very good deed;**

**WHEREAS, taking initiatives to provide temporary shelter for the health workers is a sensible and empathic way of supporting and providing them the needed comfort after work;**

**NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Clarissel J. Campaña-Moral,**

**Be it ordained by the Sangguniang Panlungsod in Regular Session assembled, that:**

**SECTION 1. TITLE - This Ordinance shall be known as "INCENTIVES FOR ESTABLISHMENTS THAT PROVIDED ACCOMMODATION FOR THE HEALTH WORKERS".**

**SECTION 2. DECLARATION OF POLICY - It is the policy of the City Government to provide incentives to business establishments for their support by providing accommodation to health workers in the administration of LGU COVID-19 programs.**

Continuation...page 2 of City Ordinance No. 20-26 (General):

**SECTION 3. IMPLEMENTING RULES AND REGULATIONS** - In the implementation of this Ordinance, the Office of the City Mayor through the following offices and entities, shall promulgate the necessary rules, regulations, guidelines and procedures:

1. Office of the City Local Enterprise, Investment and Promotions Officer,
2. Office of the City Budget Officer, and
3. Office of the City Treasurer.

**SECTION 4. TAX EXEMPTION** - Incentives received under the provision of this Ordinance shall be exempted from tax liability.

**SECTION 5. FUNDING** - For the effective implementation of this Ordinance, funding shall be allocated to be taken from the City Disaster Risk Reduction and Management Funds.

**SECTION 6. REPEALING CLAUSE** - All existing ordinances, resolutions, motion or parts thereof not consistent herewith are hereby repealed, amended or superseded accordingly.

**SECTION 7. EFFECTIVITY CLAUSE** - This Ordinance shall take effect immediately upon approval.


