ADOPTING CITY ORDINANCE NO. 20-27 DURING THE PERIOD OF GENERAL COMMUNITY QUARANTINE (GCQ).

WHEREAS, during the implementation of Enhanced Community Quarantine (ECQ), the Sanggunian approved City Ordinance No. 20-27 and set market schedules to regulate the movement of people in public and public markets, talipapa, supermarkets and grocery stores in compliance to social distancing protocol;

WHEREAS, the City's transition from Enhanced Community Quarantine (ECQ) to General Community Quarantine (GCQ) still requires people to take extra care and strict adherence to the implemented laws and guidelines for the effective control of COVID-19;

WHEREAS, some of the City's neighboring towns are still under the ECQ, thus it is necessary that we sustain protocols to avoid being exposed to the virus and preventing its spread;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Jowie S. Carampot,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as the "ADOPTING CITY ORDINANCE NO. 20-27 DURING THE PERIOD OF GENERAL COMMUNITY QUARANTINE (GCQ)".

SECTION 2. DEFINITION OF TERMS -

GENERAL COMMUNITY QUARANTINE - relaxed quarantine measures in areas identified as low and moderate-risk in the spread of COVID-19.

SECTION 3. RULES AND IMPLEMENTATION - In the implementation of this Ordinance, all the rules provided in City Ordinance No. 20-27 shall still apply.

Page 2 of City Ordinance No. 20-33 (General):

SECTION 4. EXEMPTIONS - All frontliners although prioritized during Mondays shall also be allowed to do their marketing on any days based in the alphabetical orders of customers surname as provided in Section 3 of City Ordinance No. 20-27.

SECTION 5. REPEALING CLAUSE - All orders, memoranda, rules and regulations, or any part or parts hereof, inconsistent with the provisions of this ordinance are hereby revoked or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE - If for any reason a provision of this Ordinance is declared invalid or unconstitutional, all other provisions hereof, not affected thereby, shall continue to be in full force and effect.

SECTION 7. EFFECTIVELY CLAUSE - This Ordinance shall take effect immediately upon its approval.


