AMENDING CITY ORDINANCE NO. 20-27 AND CITY ORDINANCE NO. 20-33 PERTAINING TO THE SCOPE OF ADDITIONAL PERSONS ALLOWED TO DO MARKETING IN THE PUBLIC AND PRIVATE MARKETS, TALIPAPA, SUPERMARKETS, AND GROCERY STORES IN THE CITY OF GENERAL TRIAS DURING THE PERIOD OF COMMUNITY QUARANTINE, AND PRESCRIBING NEW PENALTIES TO OWNERS OF BUSINESS ESTABLISHMENTS VIOLATING THIS ORDINANCE THEREOF.

WHEREAS, due to various circumstances, there is a need to review by addendum Section 3 of City Ordinance No. 20-27 and Section 4 of City Ordinance No. 20-33, to conform to the present situation;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Walter C. Martinez,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. PURPOSE. For purposes of this Ordinance, Section 3 of City Ordinance No. 20-27 and Section 4 of City Ordinance No. 20-33 are hereby amended by adding the provisions below and the amendment shall be read as follows:

SECTION 2. GENERAL RULE. Based in alphabetical orders of customer surnames indicated in the quarantine pass, the market day schedules for public and private markets, talipapa, supermarkets, and grocery stores are as follows except all frontliners, senior citizens (with respective quarantine pass), persons with disabilities (with valid PWD IDs), government employees and solo parents although prioritized during Mondays shall also be allowed to do their marketing on any days based in the alphabetical orders of customer surnames as provided in Section 3 of City Ordinance No. 20-27.

MONDAYS : Frontliners (Medical and Nonmedical), Senior Citizens (with Respective Quarantine Pass), Persons with Disabilities (with Valid PWD IDs), Government Employees, and Solo Parents,

**TUESDAYS, THURSDAYS
& SATURDAYS** : Surnames beginning in letters A to L,
and

**WEDNESDAYS, FRIDAYS
& SUNDAYS** : Surnames beginning in letters M to Z.

SECTION 3. PENALTIES. Any owner of business establishment who violates this Ordinance will be penalized with the following:

1st Offense - Php 3 000.00

2nd Offense - Php 5 000.00

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately.


