**CONSIDERATELY EXTENDING THE SCHEDULE OF PAYMENT OF BUSINESS TAXES AND FEES DUE FOR THE 2<sup>ND</sup> QUARTER OF 2020 WITHOUT SURCHARGES AND PENALTIES IN THE CITY OF GENERAL TRIAS UNTIL 15 JULY 2020.**

**WHEREAS, in consideration of the impact of the Coronavirus Disease 2019 (COVID-19) to local businesses, the payment without penalty of business taxes in the City of General Trias due for the 2<sup>nd</sup> Quarter of 2020 is extended until 15 July 2020;**

**WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin, be it**

**Be it enacted by the Sangguniang Panlungsod in Regular Session assembled, that:**

**SECTION 1. COVERAGE.** All annual and quarterly taxes, fees, and charges due and payable to the City Government for the 2<sup>nd</sup> Quarter of the current year can be paid not later than 15 July 2020 without penalties, surcharges, or interest.

**SECTION 2. PENALTIES AND INTEREST.** All taxes, fees, and charges due for the 2<sup>nd</sup> Quarter of the current year shall, however, be subject to those penalties and interest prescribed in the City Revenue Code if not paid on or before 15 July 2020.

**SECTION 3. REPEALING CLAUSE.** Any provisions of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended, or modified accordingly.

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.




