**ADOPTING THE EXECUTIVE ORDER NO. 16, SERIES OF 2020 PRESCRIBING THE GENERAL TRIAS PANDEMIC RESILIENCE AND SUSTAINABILITY PROTOCOLS.**

WHEREAS, in order to contain the spread of Coronavirus Disease 2019 (COVID-19) in the City, pandemic resilience and sustainable protocols were promulgated by the Local Chief Executive through Executive Order No. 16, Series of 2020;

WHEREAS, the swift and decisive action of the Local Chief Executive manifested sincere desire to augment all concerns pertaining to COVID-19, ensure the safety of the constituents, and resumption of economic activities in the City;

WHEREAS, the implementation of Executive Order No. 16, Series of 2020 shall take effect the soonest possible time;

NOW THEREFORE, on motion of SP Member Kristine Jane M. Perdito-Barison duly seconded by SP Member Jonas Glyn P. Labuguen,

Be it ordained by the Sangguniang Panlungsod, that:

**SECTION 1. TITLE** – This Ordinance shall be known as “ADOPTED GENERAL TRIAS PANDEMIC RESILIENCE AND SUSTAINABILITY PROTOCOLS ORDINANCE”.

**SECTION 2. DECLARATION OF POLICY AND OBJECTIVES** – It is the policy of the City Government to protect and promote the right of health of the people and instill health consciousness among them.

This Ordinance aims to define the minimum public health standards for COVID-19 preparedness and response strategy to mitigate the threat of COVID-19 in the City.

**SECTION 3. PENALTIES** – All persons who shall violate any of the provisions of this Ordinance and/or any applicable provision of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases guidelines in the City, shall meet the following fines and penalties pursuant to the recommendation of the Department of the Interior and Local Government (DILG).

FOR INDIVIDUALS:	
1 <sup>st</sup> Offense	A fine of P 2,500.00
2 <sup>nd</sup> Offense	A fine of P 3,000.00
3 <sup>rd</sup> Offense	A fine of P 3,500.00

FOR BUSINESS ESTABLISHMENTS:	
1 <sup>st</sup> Offense	A fine of P 2,500.00
2 <sup>nd</sup> Offense	A fine of P 3,500.00
3 <sup>rd</sup> Offense	A fine of P 5,000.00 and/or revocation of Business Permit

\*Minor offenders shall be dealt with in accordance with the provisions of R.A. No. 9344.

**SECTION 4. REPEALING CLAUSE** - All other orders, issuances and memoranda issued inconsistent herewith are hereby repealed or modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE** - Should any part or provision of this Ordinance be held contrary to law or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force effect.

**SECTION 6. EFFECTIVITY** - This Ordinance shall take effect upon its approval.


