ADOPTING THE JOINT MEMORANDUM CIRCULAR NO. 20-04-A SERIES OF 2020 ENTITLED DEPARTMENT OF TRADE AND INDUSTRY (DTI) AND DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) SUPPLEMENTAL GUIDELINES ON WORKPLACE PREVENTION AND CONTROL OF COVID-19 IN THE CITY OF GENERAL TRIAS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, the Joint Memorandum Circular No. 20-04-A series of 2020 entitled "DTI and DOLE Supplemental Guidelines on Workplace Prevention and Control of COVID-19" aims to further contain and mitigate the possible transmission of the disease in workplaces;

WHEREAS, the local government unit in adherence to the said memorandum shall follow and adopt the supplemental guidelines to further ensure the safety and health of all employees in different workplaces;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Kristine Jane M. Perdito-Barison and SP Member Clarissel J. Campana-Moral,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "SUPPLEMENTAL GUIDELINES ON WORKPLACE PREVENTION AND CONTROL OF COVID-19 ORDINANCE".

SECTION 2. DECLARATION OF POLICY - It is hereby declared the policy of the City of General Trias to adopt and implement the supplemental guidelines in the Joint Memorandum Circular No. 20-04-A to prevent the risk of transmitting the COVID-19 in workplaces.

Continuation...page 2 of City Ordinance No. 20-54 (General):

SECTION 3. COVERAGE - This Ordinance shall apply to all private business establishments regardless of economic activity including those located inside the special economic zones and other areas in the City of General Trias *except* for business establishments, such as but not limited to Semiconductor Industries, wherein implementation of certain provisions of the Joint Memorandum Circular NO. 20-04-A will cause health hazards and/or damage to its products or properties.

In such case, the said business establishments shall submit to the City Government a copy of their "Alternative Safety Protocols and Procedures" to be implemented in their workplace.

SECTION 4. MONITORING AND INSPECTION TEAM - In coordination with the DOLE and DTI, the City Health Office, Business Permit and Licensing Office, and Public Employment Service Office shall conduct regular monitoring and inspection to business establishments.

SECTION 5. ENFORCEMENT/IMPLEMENTATION. The Monitoring and Inspection Team shall issue Notice to Comply to business establishment/s to be found in violation of this Ordinance.

In case of failure to conform with this Ordinance within 10 working days from the issuance of Notice to Comply, the monitoring and inspection team will recommend to the Office of the City Mayor the issuance of temporary closure order.

SECTION 6. PENALTY - Any business establishments in violation of this Ordinance shall receive a Temporary Closure Order.

SECTION 7. IMPLEMENTING RULES AND REGULATIONS. While this Ordinance and the provisions hereof are already operative upon its effectivity, the City Mayor may issue the appropriate and relevant rules and regulation for its implementation.

SECTION 8. REPEALING CLAUSE - All orders, memoranda, rules and regulations inconsistent with the provisions of this ordinance are hereby revoked or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE. If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, not affected thereby, shall continue to be in full force and effect.

SECTION 10. EFFECTIVITY - This Ordinance shall take effect upon approval.


