**CONSIDERATELY EXTENDING THE SCHEDULE OF PAYMENT OF BUSINESS TAXES AND FEES WITHOUT SURCHARGE AND PENALTIES IN THE CITY OF GENERAL TRIAS UNTIL 10 FEBRUARY 2017.**

**WHEREAS, based on feedback and records, the extension of the schedule of payment of taxes and fees without surcharges and penalties has definitely favored the city government and the taxpayers in terms of tax collection and processing of requirements;**

**WHEREAS, for the past 2 years, the practice and consideration of extending the schedule of payment of taxes has addressed the common problems met by both the business establishments and the city government;**

**WHEREAS, Chapter 3, Section 167 of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for a justifiable reason or cause, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;**

**WHEREFORE, on motion of SP Member Florencio D. Aynos duly seconded by SP Member Hernando M. Granados, SP Member Gary A. Grepo, SP Member Jowie S. Carampot, SP Member Mario C. Amante, SP Member Kerby J. Salazar, SP Member Jonas Glyn P. Labuguen, SP Member Mario C. Amante, SP Member Walter C. Martinez, SP Member Christopher N. Custodio and SP Member Constanca S. Felizardo, be it**

**ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:**

**Section 1. TITLE. The Sanggunian considerably extends the schedule of payment of business taxes and fees without surcharge and penalties in the City of General Trias until 10 February 2017. This will be known as "Extended Schedule of Tax and Fees Payment" Ordinance.**

**Section 2. EFFECTIVITY CLAUSE. This Ordinance shall take effect after posting of copies in conspicuous places in the city has been undertaken.**




