REQUIRING ALL FINANCIAL ESTABLISHMENTS IN THE CITY OF GENERAL TRIAS TO POST OR STATION SECURITY GUARD/GUARDS IN THEIR PLACE OF BUSINESS AS CONDITIONS FOR THE ISSUANCE OF MAYOR'S PERMIT AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, based on the latest record of the City of General Trias Philippine National Police, the incidents of criminalities involving financial establishments in the city have risen in number;

WHEREAS, the designation of licensed security personnel is a deterrent to the commission of crimes against financial establishments and will help maintain peace and order and/or apprehension of law violators and preserve life and property;

WHEREAS, in line with its Peace and Order and Public Safety (POPS) Plan, the City Government of General Trias seeks to maintain peace and order and the public safety as a strategic factor to achieve economic progress and safety of people and environment;

WHEREAS, one of the priority programs in the POPS Plan is the implementation of an ordinance requiring financial establishments to designate security guards in financial establishments;

NOW, THEREFORE, on motion of SP Member Gary A. Grepo duly seconded by all Members present,

Be it enacted, as it is hereby enacted by the Sangguniang Panlungsod of General Trias, by virtue of the powers vested in it by law, in session assembled that:

SECTION 1. TITLE. This Ordinance shall be known as "Security Guard Posting Ordinance".

SECTION 2. COVERAGE. This Ordinance shall apply to financial establishments within the jurisdiction of the City of General Trias.

SECTION 3. DEFINITION OF TERMS. For this Ordinance, the following terms shall mean as follows:

Page 2 of City Ordinance No. 17-07 (General):

- a. **Financial Establishment** – any person or a group of individuals or a corporate body or a partnership firm engaged in the business of dealing with monetary transactions, such as deposits, loans, investments, remittance and currency exchange.
- b. **Posting** – the act of positioning or stationing a person assigned for security duty.
- c. **Mayor's Permit** – a legal document that offers proof of compliance with certain city laws regulating structural appearances and safety as well as the sale of products.
- d. **Licensed Security Guard** – any person who offers or renders personal service to watch or secure financial establishment/s as provided in Republic Act 5487.

SECTION 4. MANDATORY POSTING OF SECURITY GUARDS. It is hereby mandated that security guards/personnel shall be posted in all financial establishments in the City of General Trias as an additional requirement before a Mayor's Permit is issued to the establishment.

SECTION 5. IMPLEMENTING RULES AND REGULATIONS (IRR). The City of General Trias PNP and City Business Permit and Licensing Office in coordination with the Office of the City Mayor are hereby authorized to promulgate rules and regulations necessary for the effective implementation of this Ordinance.

SECTION 6. PENALTY. Failure to comply with this requirement shall be equivalent to the revocation of the Mayor's Permit issued to the involved establishments.

SECTION 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately after its required period of publication or posting.
