REGULATING THE USE OF PRESCRIBED PARKING SPACES FOR CUSTOMERS AND PRESCRIBING PENALTIES FOR NONCOMPLIANCE THEREWITH.

WHEREAS, parking area is a cleared space intended for parking vehicles;

WHEREAS, one of the reasons for the worsening traffic buildup in the City of General Trias is the misuse or nonuse of parking areas which supposedly shall be provided by the owners of business establishments to their customers, or the customers themselves parking momentarily on the road instead;

WHEREAS, many business establishments are observed to use their parking areas or any available spaces within their place of business as rental space for additional income;

WHEREAS, there is an immediate need to regulate the utilization of the parking areas to alleviate the traffic problem in the City.

NOW, THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by all Members present,

Be it ordained by the Sangguniang Panlungsod of General Trias that:

SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Regulating the Use of Prescribed Parking Spaces for Customers and Prescribing Penalties for NonCompliance Therewith."

SECTION 2. REGULATED ACTS. It is unlawful to use the prescribed parking spaces for purposes other than parking, such as, but not limited to, extension of business operation and/or rental space to other business for additional income.

SECTION 3. PENALTY. Any person or business entity who violates the provisions shall be imposed a fine of:

1st Offense : Php 2 000.00
2nd Offense : Php 3 500.00
3rd Offense : Php 5 000.00 and nonrenewal of business permit.

SECTION 4. IMPLEMENTING AGENCIES. The City Mayor through the City Business Permit and Licensing Office, City Engineering Office, General Services Office, General Trias PNP and all barangay officials shall promulgate the rules and regulations to carry out the provisions of this Ordinance.

Page 2 of City Ordinance No. 17-17 (General):

SECTION 5. SEPARABILITY CLAUSE. In the event that any clause, sentence, paragraph or part of this Ordinance shall be declared invalid or void, the other provisions shall not be affected thereby and shall continue to be in full force and effect.

SECTION 6. REPEALING CLAUSE. All ordinances, rules and regulations or any parts thereof, whose provisions are in conflict or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY. This Ordinance shall take effect fifteen (15) days upon approval of the Sangguniang Panlungsod and after compliance with posting requirements.


