PERMANENTLY CLOSING THE SITIO MARALAS BARANGAY ROAD IN BARANGAY SANTIAGO TO PAVE THE WAY THE CONSTRUCTION OF CAVITE-LAGUNA EXPRESSWAY, AND PROVIDING FOR THE CONSTRUCTION OF AN ALTERNATE ROUTE FOR THE PURPOSE.

WHEREAS, the Cavite-Laguna Expressway which will connect the provinces of Cavite and Laguna is expected to ease traffic congestion in the road networks in the said areas;

WHEREAS, providing an easier and more comfortable route to the people shall also enhance the trade and socioeconomic activities in the above-mentioned areas and the neighboring communities;

WHEREAS, the MPCALA Holdings, Inc. made a letter request address to the Local Chief Executive for an endorsement to the propose new alternate route of soon to be closed Sitio Maralas Barangay Road in Barangay Santiago;

WHEREAS, after two (2) consecutive meetings with site inspection, the Planning and Engineering Technical Team of the City Government has finally agreed to consider the request of the MPCALA Holdings, Inc. for an endorsement to higher authority the proposed alternative route;

WHEREAS, the new alternate road will improve the road level of service of Sitio Maralas in Barangay Santiago with the increase road capacity and making it more conveniently accessible to other forms of motor vehicles;

WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, permanently close any local road falling within its jurisdiction;

WHEREAS, it is further emphasized under the same section of the Code that in case of permanent closure, such ordinance must be approved by at least two thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided;

NOW THEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member Jowie S. Carampot,

Be it enacted by the Sangguniang Panlungsod, that:

SECTION 1. COVERAGE - Approximately sixty (60) metres of the barangay road at Sitio Maralas in Barangay Santiago is hereby permanently closed to pave the way for the construction of Cavite-Laguna Expressway.

SECTION 2. PROVISION - In relation to the permanent closure of the barangay road at Sitio Maralas, the following provisions shall be undertaken:

- a. Construction of the DPWH and MPCALA Holdings, Inc. of the two (2) lane new service road with approximately 364 metres in length and road right of way width of twelve (12) metres,
- b. Installation of directional and information signages on roads leading to the new service road, and
- c. Installation of streetlights along the new service road.

SECTION 3. SEPARABILITY CLAUSE - All Ordinances, Rules and Regulations, or part thereof, whose provisions are in conflict with, or contrary to the provisions of this Ordinance are hereby amended and modified accordingly.

SECTION 4. EFFECTIVITY - This Ordinance shall take effect upon its approval.


