GRANTING EXEMPTION TO DRY GOODS STALL OWNERS IN THE CITY MARKET TO PAY RENTALS DURING THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE (ECQ) FROM 15 MARCH UNTIL 15 MAY 2020 DUE TO COVID-19 PANDEMIC.

WHEREAS, during the implementation of Enhanced Community Quarantine (ECQ) the Local Government Unit (LGU) temporarily suspended the operation of dry goods stall in the City Market;

WHEREAS, COVID-19 pandemic has negatively impacted the dry goods stall owners in the City Market;

WHEREAS, dry goods stall owners in the City Market wrote a letter requesting for the waiving or suspending of their rental fees during the ECQ period;

WHEREAS, in response to the said request, the LGU decided to waive the rental fees of dry goods stall owners for the prescribed period;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Jowie S. Carampot,

Be it enacted by the Sangguniang Panlungsod, that

SECTION 1. TITLE - This Ordinance shall be known as "WAIVING OF DRY GOODS STALL RENTAL FEES DURING ENHANCED COMMUNITY QUARANTINE (ECQ) PERIOD ORDINANCE".

SECTION 2. PROVISION - The City Government of General Trias is hereby waiving/suspending the rental fees for Dry Goods Stall owners in the City Market of General Trias from 15 March to 15 May 2020 due to the implementation of Enhanced Community Quarantine (ECQ) period in relation to COVID-19 pandemic.

Copies of this Ordinance be provided to concerned offices for information and referential purposes.

SECTION 3. REPEALING CLAUSE - All Ordinances, Resolutions, Local Executive Orders or any administrative issuances found to be inconsistent with any provision or provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE - This Ordinance shall take immediately.


