IMPOSING ONE-WAY FLOW OF TRAFFIC IN PORTIONS OF JUAN LUNA STREET AND GENERAL TRIAS STREET IN BARANGAY BAGUMBAYAN FROM THE MONTHS OF DECEMBER UNTIL FEBRUARY OF EACH YEAR TO ACCOMMODATE THE VOLUMINOUS NUMBER OF CLIENTS' VEHICLES ESPECIALLY THOSE OF THE TAXPAYERS DOING BUSINESS IN THE CITY HALL.

WHEREAS, the City Government finds it difficult to accommodate the volume of vehicles being used by the taxpayers doing transactions in the City Hall;

WHEREAS, the streets of Juan Luna and General Trias in Barangay Bagumbayan surrounding the City Hall of General Trias have been consumed as parking spaces for many vehicles;

WHEREAS, the traffic situations in the said streets are observed to be heavy causing inconveniences to many;

WHEREAS, there is a need to regulate the flow of traffic in the said areas to keep the people safe and to provide the taxpayers comfort and reasonable access to premises;

NOW THEREFORE, on motion of SP Member Isagani L. Culanding duly seconded by SP Member Florencio D. Ayos,

Be it enacted by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "ONE-WAY TRAFFIC FLOW ON JUAN LUNA AND GENERAL TRIAS STREETS IN BARANGAY BAGUMBAYAN DURING THE MONTHS OF DECEMBER UNTIL FEBRUARY OF EACH YEAR ORDINANCE".

SECTION 2. REGULATED ACTS - The following streets in Barangay Bagumbayan shall be designated as One-way Streets from 6:00am to 6:00pm with the corresponding flow of traffic:

Continuation...page 2 of City Ordinance No. 21-05:

- a. Juan Luna - from Town Plaza going East bound up to Sotto Street,
and
b. General Trias - from Sotto Street going West bound to Town Plaza.

SECTION 3. PENALTIES - The violators of this Ordinance shall be penalized as follows:

First Offense : Php 1 000.00,
Second Offense : 3 000.00, and
Third Offense : 5 000.00.

SECTION 4. REPEALING CLAUSE - All Ordinances, Resolutions, Local Executive Orders or any administrative issuances found to be inconsistent with any provision or provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon approval.


