SUSPENDING THE COLLECTION OF PAYMENTS FOR MAYOR'S PERMIT IN SECURING EMPLOYMENT, OCCUPATION/CALLING NOT REQUIRING GOVERNMENT EXAMINATION, MEDICAL CERTIFICATE/HEALTH CARD, TRANSFER OF CADAVER, AND OPENING OF NICHE DURING CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC PERIOD.

WHEREAS, the Coronavirus Disease 2019 (COVID-19) pandemic has brought negative effects to employment of many Filipinos making them suffer the economic ripple effects like reduced income or job loss;

WHEREAS, many Gentriseños have been affected by the Coronavirus 2019 pandemic leaving them struggling financially;

WHEREAS, in support of the Local Government Unit to the taxpayers affected by the unprecedented challenges brought by the pandemic, payments in securing different certificates and permits shall be suspended;

WHEREAS, it is the goodwill of the City Government to ease the burden of its people concerning financial matters due to the negative impact of COVID-19 pandemic;

NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin,

Be it enacted by the Sangguniang Panlungsod, that:

Section 1. TITLE - This Ordinance shall be known as "SUSPENSION OF COLLECTION OF PAYMENTS ORDINANCE DURING COVID-19 PANDEMIC PERIOD".

Section 2. PROVISION - The City Government of General Trias is hereby waiving/suspending the collection of payments for Mayor's Permit in Securing Employment Certification, Occupation/Calling Not Requiring Government Examination, Medical Certificate/Health Card, Transfer of Cadaver, and Opening of Niche being issued by the Office of the City Mayor during COVID-19 pandemic period.

Section 4. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon approval.
