AMENDING CITY ORDINANCE NO. 20-31 PRESCRIBING NEW FARE MATRIX FOR TRICYCLES IN THE CITY OF GENERAL TRIAS DURING THE IMPOSITION OF GENERAL COMMUNITY QUARANTINE (GCQ) PERIOD.

WHEREAS, the City of General Trias recognizes and supports the directive of Governor Juanito Victor C. Remulla to review the current pricing system in view of the new public transport fare matrix guidelines;

WHEREAS, there is a need to adjust the current tricycle fare matrix in the City considering the limited number of passenger that tricycles are allowed to load per trip in relation to the emergence of national state of emergency; and

WHEREAS, the City officials have studied thoroughly the situation of tricycle operators under the Community Quarantine and came up with the holistic solution that is fair for both the riding public and the tricycle drivers/operators;

WHEREFORE, on motion of SP Member Isagani L. Culanding duly seconded by SP Member Florencio D. Ayos,

Be it Ordained by the Sangguniang Panlungsod, that

**ARTICLE I
GENERAL PROVISIONS**

SECTION 1. TITLE. This Ordinance shall be known as the "Amended Tricycle Fare Matrix in the City during Community Quarantine Ordinance".

SECTION 2. DECLARATION OF POLICY. As provided in the Local Government Code of 1991 (RA 7160), it is hereby declared the policy of the city to protect more the welfare of the public, and tricycle drivers/operators by regulating the operations of tricycles during the time when community quarantine is imposed in the City.

SECTION 3. DEFINITION OF TERMS -

3.1 COMMUNITY QUARANTINE - refers to the restriction of movement within, into or out of the area of quarantine of individuals, large groups of people, or communities, designed to reduce the likelihood

of transmission COVID-19 among persons in and to persons outside the affected area,

- 3.2 **TRICYCLE** - a motor vehicle composed of a motorcycle fitted with a single-wheeled sidecar or a motorcycle with a two-wheel cab operated to render transport services to the general public,
- 3.3 **FARE MATRIX** - list of amounts incurred/imposed for a trip from origin to destination,
- 3.4 **NEGOTIATED FARE** - a private fare that are not publicly displayed and usually set by agreements between driver and passenger/s, and
- 3.5 **FIXED FARE** - a mandated fare to be paid by various passengers using a transit vehicle.

**ARTICLE II
FARE MATRIX**

SECTION 4. COVERAGE - This Ordinance shall apply to all riding public and motorized tricycles (including back-to-back type) drivers/operators within the territorial jurisdiction of the City of General Trias.

- 4.1 All tricycles are prohibited from implementing the negotiated fare,
- 4.2 All tricycles are mandated/required to give fare discounts to elderly, disabled persons and students in the amount equivalent to 20% of the authorized fare, and
- 4.3 Fare Matrix shall be displayed conspicuously inside the vehicles for the information of the passengers.

SECTION 5. NEW FARE MATRIX DURING COMMUNITY QUARANTINE - Minimum of Fifteen Pesos (Php 15.00) for the first three (3) kilometres and additional Two Pesos (Php 2.00) for every succeeding kilometre per head.

**ARTICLE III
ADMINISTRATIVE PROVISIONS**

**ARTICLE IV
FINAL PROVISIONS**

SECTION 8. REPEALING CLAUSE - All orders, memoranda, rules and regulations, or any part or parts hereof, inconsistent with the provisions of this Ordinance are hereby revoked or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE - If, for any reason a provision of this Ordinance is declared invalid or unconstitutional, all other provisions hereof not affected thereby shall continue to be in full force and effect.

SECTION 10. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon its approval.


