MODIFYING THE POSITION ATTRIBUTES OF THE NURSING POSITIONS PURSUANT TO REPUBLIC ACT NO. 9173 (PHILIPPINE NURSING ACT OF 2002) AND THE IMPLEMENTING GUIDELINES UNDER THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) BUDGET CIRCULAR NO. 2021-2, DATED 25 AUGUST 2021.

WHEREAS, Republic Act No. 9173 or the Philippine Nursing Act of 2002 provides a minimum base pay of not lower than Salary Grade 15 for nurses working in public health institutions;

WHEREAS, as a consequence of the upgrading of the entry level nurse positions under DBM Budget Circular 2020-4, the position attributes of the remaining levels in the nurse series of positions were also modified through SP Resolution No. 03-2020-172;

WHEREAS, the latest DBM BC-2021 prescribed the Rules and Regulations on the upgrading of the previous Nurse II positions by one (1) Salary Grade (SG), as well as to provide the administrative processes for the retention of the position titles such as Nurse III;

WHEREAS, City Ordinance No. 21-43 created various plantilla positions in the City Government of General Trias which includes Nurse II positions;

WHEREAS, in a letter dated 06 September 2021, the City Human Resource Development and Management Office referred to the City Mayor the proposed modified Nurse positions in the City Government of General Trias in accordance to DBM Circular No. 2021-2;

WHEREAS, pursuant to the guidelines set in the abovementioned circular, it is just and proper to make certain modifications in the nurse positions mentioned in the letter stated above;

NOW THEREFORE, on motion of SP Member Jonas Glyn P. Labuguen duly seconded by SP Member Vivencio Q. Lozares, Jr.,

Be it enacted by the Sangguniang Panlungsod, that:
