CONSIDERATELY EXTENDING THE DEADLINE FOR THE PAYMENT OF TAXES, FEES, AND CHARGES IN THE RENEWAL OF BUSINESS PERMIT IN THE CITY WITHOUT SURCHARGES AND PENALTIES UNTIL 30 MARCH 2022; AND THE SUBMISSION OF REGULATORY REQUIREMENTS IN SECURING BUSINESS PERMIT (NEW AND RENEWAL) UNTIL 22 APRIL 2022.

WHEREAS, for the past years, the practice and consideration of extending the schedule of payment of taxes and fees without surcharges and penalties has definitely favoured the City Government and the taxpayers in terms of tax collection and processing of requirements;

WHEREAS, the City Government deemed it necessary to provide extension in payment of taxes, fees and charges, as well as in the submission of regulatory requirements to help businesses cope with the impact of the COVID-19 pandemic;

WHEREAS, Chapter 3, Section 167 of the Local Government Code of 1991 (RA 7160) provides that the Sanggunian may, for a justifiable reason or cause, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

WHEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Richard R. Parin, be it

ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:

Section 1. TITLE. The Sanggunian considerably extends the deadline for payment of business taxes, and fees in the city without surcharges and penalties until 30 March 2022, and the submission of regulatory requirements in securing business permit until 22 April 2022. This will be known as "Extended Schedule of Business Taxes, Fees and Charges Payment; and Submission of Business Permit Requirements Ordinance".

Section 2. EXTENSION OF PAYMENT FOR THE RENEWAL OF BUSINESS PERMIT. To give due consideration to local businesses which have been affected by the COVID-19 pandemic, the payment for the renewal of business permit without penalty shall be extended until 30 March 2022. However, this shall not cover arrears from previous years.

Section 3. EXTENSION FOR THE SUBMISSION OF REGULATORY REQUIREMENTS. Without prejudice to the authority of the City Government to impose sanctions to erring business establishments and its mandate to ensure the general welfare of the public, the submission of regulatory requirements in securing business permit (new and renewal) shall be extended until 22 April 2022, provided the following conditions are met by the business establishment:

- a. Is not engaged in the selling and/or storage of combustible materials;
- b. Does not encroach public roads and sidewalks;
- c. Is not included in the negative list of businesses submitted by both local and national government offices to the Business Permit and Licensing Office;
- d. Does not cause any public nuisance and/or there is no formal complaint filed against the business establishment; and
- e. Has submitted a Notarized Undertaking, a template of which is attached as Annex A and made an integral part of this Ordinance.

Failure of the business establishment to submit the required documents on the prescribed deadline and/or violation of the preceding conditions shall result to the automatic revocation of the Local Government Unit (LGU) Integrated Permit issued.

Section 4. SEPARABILITY CLAUSE. Should any part or provision of this Ordinance be held contrary to law or invalid, other parts of provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 5. REPEALING CLAUSE. All ordinances, resolutions, rules and regulations, issuances or any part thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect after posting of copies in conspicuous places in the City has been undertaken.
