TEMPORARILY CLOSING HALF OF JUAN LUNA STREET IN BARANGAY BAGUMBAYAN ON THE WHOLE DAYS OF 15 DECEMBER 2021 UNTIL 02 JANUARY 2022 TO PAVE THE WAY FOR THE FUND-RAISING ACTIVITY OF SANGGUNIANG KABATAAN FEDERATION OF THE CITY OF GENERAL TRIAS.

WHEREAS, the Sangguniang Kabataan Federation will conduct a Fund Raising-Activity along Juan Luna Street beside the City Hall and requested permission to close the half portion of it;

WHEREAS, during the conduct of the said activity which is associated with live band performance, bazaar and food park, the Sanggunian deemed it necessary to close half of Juan Luna Street to accommodate the public;

WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, temporarily close any local road;

WHEREFORE, on motion of SP Member Reienel R. Ferrer duly seconded by SP Member Alfredo S. Ching,

BE IT ENACTED by the Sangguniang Panlungsod of General Trias in Session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as "Temporary Closing Half of Juan Luna Street on 15 December 2021 Until 02 January 2022 for the Fund Raising-Activity of Sangguniang Kabataan Federation".

SECTION 2. REGULATED ACTS. The portion of Juan Luna Street in Barangay Bagumbayan shall be closed on 15 December 2021 until 02 January 2022 to pave the way for the Fund-Raising Activity of the Sangguniang Kabataan Federation of the City of General Trias.

SECTION 3. RULES AND REGULATIONS. All motor vehicles shall be restricted from entering the above-mentioned area on the scheduled dates.

Coordination with the Offices of the City Mayor and City Traffic Management for their information shall be made regarding the traffic situations along the said area during the prescribed dates.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval thereof.


