**SUSPENDING THE COLLECTION OF FEES PERTAINING TO TRICYCLE FRANCHISE (ARTICLE E AND ARTICLE N OF MUNICIPAL ORDINANCE NO. 15-05 ALSO KNOWN AS 2015 REVENUE CODE) EXCEPT TRICYCLE STICKER FEE FOR THE YEAR 2022 DUE TO CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC.**

**WHEREAS, the City Government of General Trias recognizes the integral role of tricycles in the public transport system in the City;**

**WHEREAS, the City Government also considers the difficult economic conditions being continuously experienced by the tricycle operators and drivers due to the threat of the Coronavirus Disease 2019 (COVID-19);**

**WHEREAS, the City Government ought to extend assistance to the affected drivers by waiving the collection of payment on Mayor's Permit, Filing Fee, Legal Research Fund Fee and Motorized Tricycle Operator's Permit (Franchise Fee) except for Tricycle Sticker Fee for the year 2022;**

**NOW THEREFORE, on motion of SP Member Florencio D. Ayos duly seconded by SP Member Isagani L. Culanding,**

**Be it enacted by the Sangguniang Panlungsod, that:**

**SECTION 1. TITLE - This Ordinance shall be known as "Suspension of the Collection of Fees Pertaining to Tricycle Franchise Except for Sticker Fee for the Year 2022".**

**SECTION 2. DECLARED POLICY - It is the declared policy of the City Government of General Trias to promote the interest of the members of the tricycle sector by providing them assistance and support in times of pandemic.**

**SECTION 3. PROVISION - The collection of the following Taxes/Fees on Business of Operating Motorized Tricycle (Franchise/MTOP) as provided in Article E and Article N of the 2015 Revenue Code is hereby suspended except for Sticker Fee:**

- b. Filing Fee,
- c. Legal Research Fund Fee, and
- d. Motorized Tricycle Operator's Permit (MTO) (Franchise Fee).

**SECTION 4. SEPARABILITY CLAUSE** - All Ordinances, Rules and Regulations, or part thereof, whose provisions are in conflict with, or contrary to the provisions of this Ordinance are hereby amended and modified accordingly.

**SECTION 5. EFFECTIVITY CLAUSE** - This Ordinance shall take effect immediately upon approval. Copies of this Ordinance shall be furnished to the concerned offices.


