GRANTING MANDATORY SUPPORT TO PARENTS OF TRIPLETS, QUADRUPLTS AND HIGHER MULTIPLE BIRTHS IN THE CITY; AND PROVIDING FUNDS FOR THE PURPOSE THEREFOR.

WHEREAS, mothers who gave birth to multiple babies such as triplets, quadruplets and more are often not capable to sustain the necessary expenses;

WHEREAS, in every additional babies born in set, the lower the birth weight of each baby and increases the need for admittance since most of them are premature;

WHEREAS, such birth involves higher expenses due to the use of different facilities in the hospital such as Neonatal Intensive Care Units (NICUs) which may result to longer confinement and more frequent hospital visits after birth;

WHEREAS, the City Government deemed it necessary to support the parents to ensure that they can provide all expenses relative thereof;

WHEREAS, the Local Government Code of 1991 in Section 16 provides that local governments shall exercise powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare;

WHEREFORE, on motion of SP Member Clarissel J. Campaña-Moral duly seconded by SP Member J-M Vergel M. Columna, be it

ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "SUPPORT TO PARENTS OF TRIPLETS, QUADRUPLTS AND HIGHER MULTIPLE BIRTHS IN THE CITY; AND PROVIDING FUNDS FOR THE PURPOSE THEREFOR".

Continuation...page 2 of City Ordinance No. 22-17 (General):

SECTION 2. DEFINITION OF TERMS

1. Triplets – give birth of three babies,
2. Quadruplets – give birth of four babies, and
3. Multiple births – more than four babies.

SECTION 3. RULES AND REGULATIONS – Mothers who gave birth to triplets, quadruplets and higher multiple births are covered by this Ordinance based on the criteria set by the City Civil Registrar's Office and City Social Services Welfare and Development Office (CSWDO).

1. For Triplets - Fifty Thousand Pesos (Php 50 000.00) Cash, and
2. For Quadruplets and higher – Sixty Thousand Pesos (Php 60 000.00) Cash.

SECTION 4. APPROPRIATION – The funds necessary for the mandatory support to parents of triplets, quadruplets and higher multiple births in the city shall be taken from the City funds.

SECTION 5. REPEALING CLAUSE – Any existing Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE – This Ordinance shall take effect upon its approval.


