**PRESCRIBING THE STA. CLARA BRIDGE A TEMPORARY ONE-WAY THOROUGHFARE FROM 4:00 A.M. UNTIL 10:00 P.M. AND ITS CLOSURE ONWARDS TO FAST-TRACK THE IMPLEMENTATION OF THE BRIDGE WIDENING PROJECT STARTING 07 OCTOBER 2022 UNTIL ITS COMPLETION.**

**WHEREAS, it is economically beneficial to widen the Sta. Clara Bridge to reduce traffic congestion in the area brought about by the influx of vehicles passing thereat;**

**WHEREAS, prescribing Sta. Clara Bridge as one-way thoroughfare from 4:00 a.m. until 10:00 p.m. and its closure onwards are necessary to fast-track the implementation of the bridge widening project and allow the movement of construction workers, materials and equipment on the site as needed;**

**WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit, pursuant to an ordinance, may temporarily close roads within its jurisdiction;**

**WHEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member J-M Vergel M. Columna,**

**Be it enacted by the Sangguniang Panlungsod, that:**

**SECTION 1. TITLE - This Ordinance shall be known as "PRESCRIBING THE STA. CLARA BRIDGE A TEMPORARY ONE-WAY THOROUGHFARE FROM 4:00 A.M. UNTIL 10:00 P.M. AND ITS CLOSURE ONWARDS FOR BRIDGE WIDENING PROJECT ORDINANCE".**

**SECTION 2. ROAD CLOSURE DETAILS - The Sta. Clara Bridge will be temporarily prescribed as a one-way thoroughfare from 4:00 a.m. until 10:00 p.m. and its closure onwards for the implementation of the bridge widening project starting 07 October 2022 until its completion.**

Continuation...page 2 of City Ordinance No. 22-31 (Special):

**SECTION 3. ALTERNATE ROADS FOR ALL TYPES OF TRANSPORT SYSTEM** – All motorists are directed to utilize alternate roads such as Bgy. Vibora-Arnaldo-Sta. Clara, Bgy. Sta. Clara-Pinagtipunan, and Bgy. San Juan I-Pinagtipunan to and from their respective destination.

**Section 4. REPEALING CLAUSE** – All ordinances, resolutions, rules and regulations, issuances or any part thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

**Section 5. EFFECTIVITY CLAUSE** – This Ordinance shall take effect immediately upon approval.




