PRESCRIBING THE STA. CLARA BRIDGE A TEMPORARY ONE-WAY THOROUGHFARE FROM 4:00 A.M. UNTIL 10:00 P.M. AND ITS CLOSURE ONWARDS TO FAST-TRACK THE IMPLEMENTATION OF THE BRIDGE WIDENING PROJECT STARTING 07 OCTOBER 2022 UNTIL ITS COMPLETION.

WHEREAS, it is economically beneficial to widen the Sta. Clara Bridge to reduce traffic congestion in the area brought about by the influx of vehicles passing thereat;

WHEREAS, prescribing Sta. Clara Bridge as one-way thoroughfare from 4:00 a.m. until 10:00 p.m. and its closure onwards are necessary to fast-track the implementation of the bridge widening project and allow the movement of construction workers, materials and equipment on the site as needed;

WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit, pursuant to an ordinance, may temporarily close roads within its jurisdiction;

WHEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member J-M Vergel M. Columna,

Be it enacted by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "PRESCRIBING THE STA. CLARA BRIDGE A TEMPORARY ONE-WAY THOROUGHFARE FROM 4:00 A.M. UNTIL 10:00 P.M. AND ITS ONWARDS WIDENING PROJECT CLOSURE FOR BRIDGE ORDINANCE".

SECTION 2. ROAD CLOSURE DETAILS - The Sta. Clara Bridge will be temporarily prescribed as a one-way thoroughfare from 4:00 a.m. until 10:00 p.m. and its closure onwards for the implementation of the bridge widening project starting 07 October 2022 until its completion.

Continuation...page 2 of City Ordinance No. 22-31 (Special):

SECTION 3. ALTERNATE ROADS FOR ALL TYPES OF TRANSPORT SYSTEM – All motorists are directed to utilize alternate roads such as Bgy. Vibora-Arnaldo-Sta. Clara, Bgy. Sta. Clara-Pinagtipunan, and Bgy. San Juan I-Pinagtipunan to and from their respective destination.

Section 4. REPEALING CLAUSE – All ordinances, resolutions, rules and regulations, issuances or any part thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 5. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon approval.
