ADOPTING REPUBLIC ACT NO. 11897, AN ACT DECLARING THE 2ND THURSDAY OF JANUARY OF EVERY YEAR AS SPECIAL WORKING HOLIDAY TO BE KNOWN AS "NATIONAL BAPTIST DAY".

WHEREAS, the City recognizes the contributions of the Baptist Churches in the City particularly with their efforts in maintaining lasting peace as well as giving people sense of fulfillment and purpose in their fellowship through spiritual development of the faithfuls;

WHEREAS, the City Government also lauds the Baptist Churches in the City in providing spiritual-based services and Christian teachings to City employees, schools, communities and prisoners;

WHEREAS, in recognition and appreciation of the important role the Baptist Churches play in spiritual development of the people of General Trias, the City Government adopts Republic Act No. 11897 whereby declaring the 2nd Thursday of January of every year as Special Working Holiday in celebration of National Baptist Day;

NOW THEREFORE, on motion of SP Member Hernando M. Granados duly seconded by SP Member Jowie S. Carampot,

Be it enacted by the Sangguniang Panlungsod, that:

SECTION 1. TITLE - This Ordinance shall be known as "BAPTIST DAY OF THE CITY OF GENERAL TRIAS ORDINANCE".

SECTION 2. DECLARATION OF POLICY - It is the policy of the City Government of General Trias to recognize and support the Baptists Churches for the continuous pursuit of their evangelical mission to contribute to nation-building by proclaiming, teaching and sharing biblical principles for the betterment of the society.

SECTION 3. CELEBRATION - As provided in Republic Act No. 11897, the 2nd Thursday of January of every year is hereby declared and observed as the National Baptist Day and proclaimed the same as a Special Working Holiday in the City.

Continuation...page 2 of City Ordinance No. 22-38 (Special):

SECTION 4. IMPLEMENTATION - The City of General Trias through the Office of the City Mayor in coordination with other offices or personnel as may be deputized by the Local Chief Executive shall promote and implement the citywide celebration of the National Baptist Day annually.

SECTION 5. FUNDING - The City Government shall appropriate funds for the implementation of this Ordinance.

SECTION 6. EFFECTIVITY - This Ordinance shall take effect upon its approval and posting in any conspicuous places in the City.


