APPROVING THE CITY OF GENERAL TRIAS DISASTER RISK REDUCTION AND MANAGEMENT IN HEALTH (DRRM-H) PLAN SUBJECT TO EXISTING LAWS, RULES, AND REGULATIONS.

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 11 (1) (iv) of Republic Act 10675 otherwise known as the Charter of the City of General Trias states that the Sangguniang Panlungsod shall approve ordinances and pass resolutions necessary for an efficient and effective city government and, in this connection, shall adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance to victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events;

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, states that it is the policy of the State to maintain disaster risk reduction and climate change in development processes such as policy formulation, socioeconomic development planning, budgeting and governance;

WHEREAS, Administrative Order No. 2020-0036 issued by the Department of Health (DOH) provides the guidelines on the institutionalization of Disaster Risk Reduction and Management in Health (DRRM-H) Plan in the Citywide Health Systems to develop an efficient and effective preparedness and response to public health emergencies and disasters, thus, ensuring delivery of essential population-based health services;

WHEREAS, the City of General Trias Disaster Risk Reduction and Management Council (CDRRMC), in a recent special meeting, adopted CDRRMC Resolution No. 001, Series of 2022 which approves the City of General Trias Disaster Risk Reduction and Management in Health (DRRM-H) Plan, a copy of such Resolution, including its supporting documents, is hereto attached and made an integral part hereof as Annex "A";

WHEREAS, after thorough examination of available documents relevant to the subject proposed legislative measure, the Sangguniang Panlungsod of the City of General Trias deems it necessary to enact this Ordinance.

NOW THEREFORE, on motion of SP Member Isagani L. Culanding duly seconded by SP Member Kristine Jane M. Perdito-Barison,

Be it ordained by the Sangguniang Panlungsod, that:

SECTION 1. The City Disaster Risk Reduction and Management in Health (DRRM-H) Plan, attached and made integral part of this Ordinance as Annex "B", approved subject to existing laws, rules, and regulations.

SECTION 2. SEPARABILITY CLAUSE – If any of the sections or provisions of this Ordinance is held invalid, all the other provisions not affected thereby shall remain valid.

SECTION 3. REPEALING CLAUSE – All ordinances, resolutions, rules and regulations, issuances or any part thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 4. Let the Office of the City Mayor, Office of the City Administrator, Legal Department, City of General Trias Disaster Risk Reduction and Management Office, City Health Office, City Information Office, Community Affairs Division, Department of the Interior and Local Government–City of General Trias, and other concerned offices for their information, guidance and reference be furnished copies of this Ordinance.

SECTION 5. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval.
