**TEMPORARILY CLOSING THE PORTION OF ARNALDO HIGHWAY IN BARANGAY SAN FRANCISCO FOR THE CONSTRUCTION OF CAVITE-LAGUNA EXPRESSWAY (CALAX) OVERPASS BRIDGE-3 FROM 23 JANUARY 2023 UNTIL ITS COMPLETION AND IMPLEMENTING A DETOUR FOR THE PURPOSE.**

**WHEREAS, the Cavite-Laguna Expressway (CALAX) which will connect the provinces of Cavite and Laguna is expected to ease traffic congestion in the road networks of the said areas;**

**WHEREAS, providing an easier and more comfortable route to the people shall also enhance the trade and socioeconomic activities in the abovementioned areas and the neighboring communities;**

**WHEREAS, to avoid inconvenience to the public, a detour will be implemented to improve the flow of traffic in Arnaldo Highway in Barangay San Francisco while the construction of the said project is ongoing;**

**WHEREAS, meetings and coordination with stockholders were conducted for the purpose;**


**WHEREAS, Section 21 of the Local Government Code of 1991 (RA 7160) provides that a local government unit may, pursuant to an ordinance, temporarily close any local road within its jurisdiction;**


**NOW THEREFORE, on motion of SP Member Richard R. Parin duly seconded by SP Member J-M Vergel M. Columna,**


**Be it enacted by the Sangguniang Panlungsod, that:**


**SECTION 1. TITLE - This Ordinance shall be known as "TEMPORARY CLOSURE OF THE PORTION OF ARNALDO HIGHWAY, CITY OF GENERAL TRIAS, CAVITE FOR CAVITE CALAX ARNALDO OVERPASS BRIDGE-3 PROJECT ORDINANCE".**


**SECTION 2. COVERAGE - This Ordinance covers the portion of Arnaldo Highway in Barangay San Francisco for the construction of Cavite-Laguna Expressway (CALAX) Overpass Bridge-3 from 23 January 2023 until its completion.**





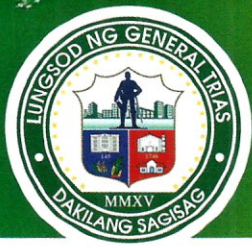

Continuation...page 2 of City Ordinance No. 23-03 (Special):

**SECTION 3. PROVISION - In relation to the temporary closure of the portion of Arnaldo Highway in Barangay San Francisco, the following provisions shall be undertaken:**

- a. Construction of diversion road with approximately 172 metres in length and road width of fourteen (14) metres;
- b. Installation of directional and information signages on roads leading to the new service road; and
- c. Installation of streetlights along the new service road.

**SECTION 4. SEPARABILITY CLAUSE - If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, not affected thereby, shall continue to be in full force and effect.**

**SECTION 5. EFFECTIVITY - This Ordinance shall take effect immediately upon approval.**
