EXTENDING THE SUSPENSION OF THE COLLECTION OF FEES PERTAINING TO TRICYCLE FRANCHISE EXCEPT TRICYCLE STICKER FEE FOR THE YEAR 2023 DUE TO FUEL PRICE HIKES.

WHEREAS, the City Government of General Trias acknowledges the vital role of tricycles in the public transportation system being the most convenient mode of transport catering the trips of people in different places in the City;

WHEREAS, the City Government also considers the difficult economic conditions being continuously experienced by the tricycle operators and drivers due to successive fuel price increase in the country;

WHEREAS, the City Government ought to extend the waiving of payment on Mayor's Permit Fee, Filing Fee, Legal Research Fund Fee and Motorized Tricycle Operator's Permit (MTO) (Franchise Fee) except for Tricycle Sticker Fee for the year 2023 as assistance to the affected operators and drivers;

NOW THEREFORE, on motion of SP Member J-M Vergel M. Columna duly seconded by SP Member Felix A. Grepo,

Be it enacted by the Sangguniang Panlungsod, that:


SECTION 1. TITLE - This Ordinance shall be known as "EXTENSION ON THE SUSPENSION OF THE COLLECTION OF FEES PERTAINING TO TRICYCLE FRANCHISE EXCEPT FOR STICKER FEE FOR THE YEAR 2023 ORDINANCE".


SECTION 2. DECLARED POLICY - It is the declared policy of the City Government of General Trias to promote the interest of the members of the tricycle sector by providing them assistance and support in times of fuel price hikes.


SECTION 3. PROVISION - The collection of the following taxes/fees on Business of Operating Motorized Tricycle as provided in Article E and Article N of the 2015 Revenue Code is hereby suspended except for Sticker Fee:


- Mayor's Permit Fee;**
- Filing Fee;**
- Legal Research Fund Fee; and**
- Motorized Tricycle Operator's Permit (MTO) (Franchise Fee).**
