**AMENDING SECTION 103 OF CITY ORDINANCE NO. 22-21 ALSO KNOWN AS THE "REVISED CITY TRAFFIC MANAGEMENT CODE OF 2022" WHEREBY PRESCRIBING NEW TRUCK BAN SCHEDULE FOR 10-WHEELER TRUCKS AND UP; ENFORCING ADDITIONAL RESTRICTION FOR 6 to 8-WHEELER TRUCKS; AND IDENTIFYING THE SPECIFIED TRUCK BAN ROUTES IN THE CITY.**

**WHEREAS, while trucks remain one of the fastest and most efficient solution for the transport of goods and cargos, it is evident that such vehicles occupy much space in the road contributing largely to the traffic congestion in the City;**

**WHEREAS, to help ease the worsening traffic congestion and regulate the presence and operation of trucks, the City Government has decided to regulate truck operation on certain roads within specified days and hours;**

**WHEREAS, it has become necessary to amend certain provisions of the Revised City Traffic Management Code of 2022 in order to impose new restrictions and ensure a safer and better transport operation;**

**NOW THEREFORE, on motion of SP Member J-M Vergel M. Columna duly seconded by SP Member Isagani L. Culanding,**

**Be it ordained by the Sangguniang Panlungsod of General Trias, that:**

**SECTION 1. TITLE – This Ordinance shall be known as "NEW TRUCK BAN SCHEDULE AND ROUTES IN THE CITY OF GENERAL TRIAS ORDINANCE".**

**SECTION 2. NEW TRUCK BAN SCHEDULE AND ROUTES – The new schedule for the operation of trucks in the City shall be impose as follows:**

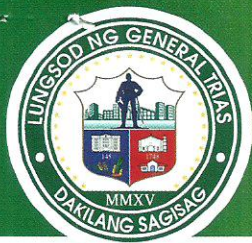

**SECTION 3. TRUCK BAN SIGNS AND SIGNAGE/S** - The Office of the City Mayor through the City Traffic Management Office (CTMO) shall be responsible for the installation of the necessary signages on conspicuous places to inform the public of the new truck ban schedule and routes.

**SECTION 4. IMPLEMENTING AGENCY** - This Ordinance shall be implemented by the Office of the City Mayor through the City Traffic Management Office (CTMO), General Trias City Philippine National Police (PNP) and other offices or personnel as may be deputized.

**SECTION 5. REPEALING CLAUSE** - All ordinances, resolutions, circulars, letters of the instruction, memorandums, and rules and regulations inconsistent with the provision of the Ordinance are hereby repealed and modified accordingly.

**SECTION 6. EFFECTIVITY CLAUSE** - This Ordinance shall take effect after posting of copies in conspicuous places in the City has been undertaken.


