NOW THEREFORE, on motion of SP Member Alfredo S. Ching duly seconded by SP Member Vivencio Q. Lozares, Jr.,


Be it enacted by the Sangguniang Panlungsod, that:



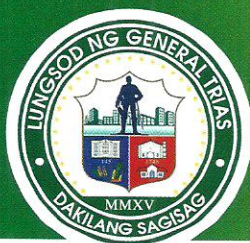

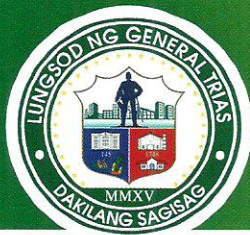
