**TRANSFERRING THE HEAVY EQUIPMENT OPERATOR II AND HEAVY EQUIPMENT OPERATOR I POSITIONS FROM THE OFFICE OF THE CITY MAYOR (HEAVY EQUIPMENT SERVICE UNIT) TO THE OFFICE OF THE CITY ENGINEER.**

**WHEREAS, it is deemed proper to transfer the Heavy Equipment Operator II and Heavy Equipment Operator I positions from the Office of the City Mayor (Heavy Equipment Service Unit) to the Office of the City Engineer since their mandated functions are connected with the said office;**

**WHEREAS, the Office of the City Engineer is in need of Heavy Equipment Operators to oversee the operation and conduct routine maintenance of various equipment owned by the City Government;**

**WHEREAS, the transfer of the abovementioned positions shall be made in accordance with the Civil Service laws, rules and regulations, and the Local Budget Circular No. 137 (Index of Occupational Services, Position Titles and Salary Grades in the Local Government);**

**NOW THEREFORE, on motion of SP Member Alfredo S. Ching duly seconded by SP Member Vivencio Q. Lozares, Jr.,**

**Be it enacted by the Sangguniang Panlungsod, that:**

**Section 1. TITLE - This Ordinance shall be known as "TRANSFERRING THE HEAVY EQUIPMENT OPERATOR POSITIONS TO THE OFFICE OF THE CITY ENGINEER ORDINANCE".**

**Section 2. PURPOSE - To meet the needs of the present demand of a very functional and responsive government institution, it is imperative to transfer some plantilla positions on different office.**

**Section 3. TRANSFER OF PLANTILLA POSITIONS - The following positions are hereby transferred from the Office of the City Mayor (Heavy Equipment Service Unit) to the Office of the City Engineer:**

- a. Heavy Equipment Operator II, SG-6, Item No. 405 (Old 313); and**
- b. Heavy Equipment Operator I, SG-4, Item No. 406 (Old 314).**



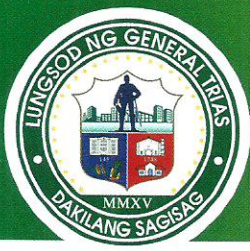

Continuation...page 2 of City Ordinance No. 23-19 (Special):

**Section 4. SEPARABILITY CLAUSE** – If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, not affected thereby, shall continue to be in full force and effect.

**Section 5. REPEALING CLAUSE** – All ordinance, resolutions, rules and regulations, issuances or any part thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

**Section 6. EFFECTIVITY CLAUSE** – This Ordinance shall take effect upon its approval.
