AMENDING SECTION 2 (A) OF MUNICIPAL ORDINANCE NO. 15-03 ALSO KNOWN AS "THE GENERAL TRIAS SPORTS COMPLEX, GENERAL TRIAS CULTURAL AND CONVENTION CENTER, AND GENERAL TRIAS SPORTS PARK RATES AND FEES ORDINANCE" WHEREBY CHANGING THE RATES AND FEES IN AVAILING THE GENERAL TRIAS CULTURAL AND CONVENTION CENTER.

WHEREAS, Section 129 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy. Such taxes, fees, and charges shall accrue exclusively to the local government units;

WHEREAS, to ensure the proper maintenance of the General Trias Cultural and Convention Center, contribute to the upkeep of it, and keep up with inflation, increasing the fees and charges for its use with or without the other facilities therein, is deemed necessary;

NOW THEREFORE, on motion of SP Member Jesse Raphael R. Grepo duly seconded by SP Member Jowie S. Carampot,

Be it enacted by the Sangguniang Panlungsod, that:


Section 1. TITLE – This Ordinance shall be known as the "AMENDED RATES AND FEES IN GENERAL TRIAS CULTURAL AND CONVENTION CENTER ORDINANCE".

Section 2. PURPOSE – For the purposes of this Ordinance, Section 2 (A) of Municipal Ordinance No. 15-03 is hereby amended to be read as follows:

A. General Trias Cultural and Convention Center

FACILITIES	FEES/CHARGES
a. With Air Conditioning Unit	Six Thousand Pesos (Php 6 000.00) per hour
b. Without Air Conditioning Unit	Three Thousand Pesos (Php 3 000.00) per hour
c. Chairs	Ten Pesos (Php 10.00) per chair
d. Corkage	Ten Thousand Pesos (Php 10 000.00)

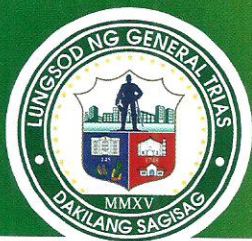

e. Minimum Electric Consumption Fee	One Thousand Pesos (Php 1 000.00)
f. LED Wall	Ten Thousand Pesos (Php 10 000.00)

Section 3. IMPLEMENTING AGENCY – This Ordinance shall be implemented by the Office of the City Mayor through the Office of the City Engineer and other office or personnel as may be deputized.

Section 4. REPEALING CLAUSE – All ordinance, resolutions, rules and regulations, issuances or any part thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 5. EFFECTIVITY CLAUSE – This Ordinance shall take effect on the first day of the ensuing quarter after copies of it have been posted in three (3) conspicuous places in the City.


